EVENTS CELEBRATE 20 YEARS OF QUEENS PRIDE

Queens Pride will celebrate the 20th Pride Parade and Multicultural Festival on Sunday, June 3 with a host of activities to promote pride among and for the Lesbian, Gay, Bisexual, Transgender and Queer/Questioning (LGBTQ) community of Queens and beyond. A new edition to Queens Pride this year, banners already announce the 37th Avenue route of the Parade and Multicultural Festival.

The theme, "A Generation of Pride in Queens," acknowledges the 20 years of leadership and advocacy that have advanced the causes of the LGBTQ community. This year's Grand Marshals are the Family of Julio Rivera, the young man whose murder in 1990 led to the founding of the Parade, and Queens Center for Gay Seniors (formerly SAGE Queens). "Our Grand Marshals reflect the difficult struggles that the LG-BTQ community has faced and the need to remain supportive and vigilant to advance our efforts," says Chris Calvert, Co-Chair, Queens Pride.

Assisting with the parade this year will be the Pride Posse, consisting of members of high school Gay Student Alliances and other student advocacy organizations. "The Pride Posse represents the new generation of the LGBTQ community who will carry forth

our causes well into the future," says Mr. Calvert. A special contingent this year will be members of the Broadway cast of Wicked.

The Parade will kick-off at 12PM at 84th Street and 37th Avenue, ending at 75th Street. Marcus Woolen and Candy Samples will host a reviewing stand in front of the Jackson Heights Post Office, which is where the Queenie Awards are judged. The awards honor the ingenuity and enthusiasm of groups in their demonstration of LGBTQ pride and the theme of this year's event.

The Festival begins at 11AM with nearly 100 vendors along 37th Road and 75th Street. Two stages will feature entertainment throughout the day. The festival will cap off with a performance by Martha Wash, who is marking the 30th Anniversary of the Weathergirls smash hit, It's Raining Men. Hank Krumholz, Co-Chair of Queens Pride says, "Martha Wash is a long-time icon for our community, and her music is sure to energize the crowd."

Queens Pride is also collaborating on a number of events to surround the parade and festival. On Thursday, May 31, Queens Pride, New York Pride, and Councilmembers Dromm and Van Bramer will help kick-off pride with a party at Studio Square in Long Island City (3533)

36th Street). The party will take place from 6PM to 9PM with drink specials and entertainment throughout the evening.

In partnership with Barefoot Wine and Bubbly and Out Astoria, Novo Restaurant and Lounge (7823 37th Avenue), will host the Barefoot Brunch on Sunday, June 3. The brunch lasts from 11AM to 4PM and will offer pride spectators an opportunity to cool off with Barefoot Bubbly cocktails. Proceeds from the event will benefit Queens Pride and Out Astoria.

On Sunday, June 3, there will be a special screening of Julio of Jackson Heights. Documentary filmmaker and photographer Richard Shpuntoff, has been documenting Queens Pride since its beginnings. The film tells the tale of how the LGBTQ population of Jackson Heights came together in response to the 1990 gay bashing murder of Julio Rivera in the P.S. 69 schoolyard. "Richard has been dedicated to completing the project, and we look forward to a special screening of his progress," savs Mr. Calvert. The screening will begin at 7PM at Renaissance Charter School, 3559 81st Street. Jackson Heights.

Council Member Mark Weprin Proposes To Increase Fines For Illegal Signs

Council Member Mark Weprin (D-Oakland Gardens) will introduce legislation to triple the current fines for illegally posting signs on public property. Recently, along Hillside Avenue in Bellerose as well as in other parts of the City, there has been a spate of illegal signs on public property, creating blight in the affected neighborhoods. Illegal signs can be distracting for motorists, causing safety concerns; the signs can also deface public property ultimately straining resources when it is time for the City to clean up.

"The number of illegal signs is multiplying, and we must increase both fines and enforcement to discourage this pattern from continuing," said Council Member Mark Weprin. "Illegal signs are an unsightly blemish on our neighborhoods. The increasing quantity posted on street lights and utility poles is a distraction to passing motorists. It seems that when these signs are removed by the NYC Department of Sanitation, new ones appear in a very short time," said Jerry Wind, President of the Bellerose Hillside Civic Association.

"When signs eventually fall off, they can create a hazard, as the nails used to affix them are exposed; the signs litter our streets, gardens and parks. It's just another form of graffiti that is bringing down the quality of life in our communities," said Frederick Kress, coordinator at Citizens Against Graffiti Everywhere.

"Now that those who post

these signs are resorting to cementing them to the metal poles, traffic signs, traffic boxes and street signs, the illegal signs are damaging public property. Not only should violators be fined for posting the signs, but a fine should be issued for vandalism," said Michael Augugliaro, member of Queens Colony Civic Association.

Council Member Mark Weprin's legislation would triple fines for posting stickers, fliers, and other advertisements on telephone poles, garbage cans, lampposts or other public property illegally. Increasing fines would exemplify the seriousness of the effort to discourage criminals and make enforcement a priority of the NYC Department of Sanitation.

Congressman Crowley Applauds Decision to Keep Queens Postal Facility Open

Rep. Joe Crowley (D-Queens, the Bronx) issued the following statement following the announcement by the United States Postal Service (USPS) that the Queens Processing and Distribution Center will remain open:

"I am so glad the Queens Processing and Distribution Center will remain open and will continue to serve the Queens community. Closing this facility would have severely impacted businesses and residents in the community that rely on the center day in and day out. It also would have stripped away hundreds of jobs from Queens at a time when we need every job we can get. That's why I worked hard to help fight efforts to close this facility and express the concerns of the community to officials at USPS. Now, with the decision to keep this facility open, we can ensure the community will continue to have access to the essential services USPS provides and hundreds of jobs will remain in Queens."

Crowley is a co-sponsor of H.R.

1351, legislation that will free the Postal Service from pre-paying its pension obligations in an effort to alleviate the financial burden facing the Postal Service. Crowley has been a leader in efforts to save community post offices in the Bronx and Queens. He rallied against the closure of the Queens Processing and Distribution Center, met with representatives of the Flushing APWU, as well as called on Triboro District Postmaster to express his concerns about the potential closing.







GOING NORTH TO WESTCHESTER by Merle Exit

Westchester County is just north of the Bronx here in New York City. I went online to see what I could do for a weekend. My friend Laurie loves to drive so off we went on Friday morning with the first destination being a nature center called Beczak Environmental Education Center in the city of Yonkers and located along the Hudson River.

They present exhibits and programs for all ages to raise environmental awareness and encourage informed stewardship of the Hudson River, the Saw Mill River and the Bronx River. It's mostly for kids. Learning programs includes hopping aboard a fishing boat and checking out the creatures that dwell in the rivers. I was busy checking out the turtles in the tanks.

Just outside in the back are these pieces of artwork sitting along a fence. Recycled and "framed". Two dimensional and depicting the history of the area.

Down the block, so to speak, is a place called The Barge, another environmental center run on solar panels. It's another thing for kids to learn about the cleaning up of the Hudson River. What's special about The Barge is that they grow hydroponic plants and vegetables.

A walk away is an area with some shops and restaurants. One restaurant that jets out over the Hudson is called X20 aka Peter Kelly's X20. That's where we had lunch.

Unfortunately they only serve sushi in the evening, but I did start the meal with some great Sake. Smoked Salmon Spring Roll with Goat Cheese & Damp; Mango was just a bit more than an amuse bouche sent out by the chef. It set me up for an expectation of how good the food would be.

Roasted Fennel Soup served with Pumpkin Seed Oil and Fennel Fronds sounded interesting and tasted great (I wonder if they stomp on pumpkin seeds to get the oil). Ît didn't have an overpowering licorice flavor and I happen to be Frond of fennel.

Salad is a must for me. This one had Heirloom Beets (not just the red ones) and Field Lettuce topped with crumbled goat cheese. Mmmmm...tasty.

Since I couldn't have sushi I ordered Soft Shell Crab Tempura. It was served over Mesclun & amp: Heirloom Beets (beets are good for you) with Spring Ramps (a wild green veggie) and Jalapeno

We then ordered our entrees. Pan Seared Montuak Skate Wing with Robuchon Potatoes & Damp; Asparagus topped with a balsamic brown butter and Lemon Crumbs. Robuchon potatoes are cooked in lightly salted water with skins on. After draining the potatoes are then peeled and put through a food mill. Then they are dried out over a low flame and emulsified with butter and milk. Now if that isn't enough to achieve a texture, they are passed through a fine sieve. It's almost like sipping mashed



potatoes. Loved it and the rest of the dish.

The second entree was Ravioli with Short Ribs & Drie Gras in Truffle Butter with Broccoli Rabe and Grated Amoretti (I'll have to ask again as to what this is). Entree was sooooo delicious.

Got some samplings of dessert (Can you say, "doggie bag?"). House Made Grand Marnier Ice Cream. I can't resist tasting house made ice creams. Classic Carrot Cake made with Mascarpone Frosting and Rum Anglaise. Liked that it didn't have a "spice" taste. Warm Soft Chocolate Cake with Pistachio Ice Cream. Close to having one of those chocolate lava cakes...mmmmm....chocolate. Will have to return for dinner some time...after a few hours on the tread mill.

After that fabulous lunch we set off to Mt. Kisco with the first stop at Epidavros Day Spa on North Bedford Road. I had a facial. I don't know exactly which one it was (I will find out when Sandra, the owner, talks on my radio show. All I know that it that there were layers of wonderful stuff put on and taken off my face to make it moist and smooth. I was also given a much need foot massage.

I wanted to sleep afterward but it was time for Laurie and I to check into the hotel. Holiday Inn, located on Holiday Inn Drive (I wonder if I can get the name of my street changed to Merle Exit Lane) in Mt. Kisco. Laurie and I each had our own room as I tend to snore and want to keep this long time friendship going. Not wanting to bring my Netbook, I found that they had a few computers so I was able to check my email. A full buffet breakfast is included. I had asked for a frig in my room so I could store any leftovers or any other goodies that I bought.

Next on the agenda was the Westchester Dinner Theatre located in Elmsford. Legally Blonde, the musical was being performed. I did see the show on Broadway but it was years ago and didn't remember it enough to make a comparison. I can't tell vou how many times I've seen the movie on television. Talent wise, the show was quite good. The food is pretty good. There is certainly a long list of other food and drinks to be purchased beyond

the salad, entree and dessert to include coffee or tea. Hairspray is the next show coming up. www. broadwaytheatre.com

The next morning we decided to view the downtown area of Mt. Kisco. Connie's Bakery & Damp; General Store seemed like an interesting shop. Their thing is that they give 100% of the profits to charity. General Store portion had much chachkas to choose from. Great baked goods of cookies and cakes. Sampled some cookies, and other tasty items. Problem is that they may not be there for long. There were two other shops that we wanted to visit (a list of "what's around" was provided by the hotel...they need to update the list) but they were closed...like forever.

Now, lunch was most interesting. There is this what I would call an "Entertainment Center". The two main attractions are the Grand Prix race cars and the Spins Bowling. In between there are bouncy areas for kids as well as a restaurant. Actually the name of the place is Grand Prix New York (also in Mt. Kisco). Laurie and were using both of our gps to find it. The trip kept on being a hoot to hear each of the women giving directions. Grand Prix is not on North Bedford itself as you have to go down a ramp. Thank goodness for signs. We had lunch at their Fuel Restaurant. I would recommend eating here even if you're not participating. I started off with a tasty drink that had a wee bit of alcohol and looked like an ice cream float. We had a chicken salad, rack of ribs and mac and cheese topped with bacon. I thought that the ribs might be the kind that comes precooked and vacuumed sealed. However, I am told that the ribs are freshly smoked and cooked on the premises. I'm impressed! I had not intention of racing around the indoor track. Laurie was much braver than I. These race cars get up to a speed of 40 mph. Okay, I have to admit that it's the getting in and out of the low vehicle that I can't do. Hey it was about 10 or so years ago when I found myself faced with a window to climb into.

That afternoon we spent a short time at another nature venue called Teatown, which had

Prepare Your Kids for Summer Job Expenses

High school and college students hoping to find temporary jobs may be in for a tough time this summer – once again – as they compete with older, more experienced workers in a still-struggling economy. But if your kid is fortunate enough to find work, there are a few things he or she – and you – should know about the economic and tax ramifications of temporary employment:

Payroll deductions. If this is their first job, warn your kids about common payroll deductions that can take a big bite out of take-home pay. Common culprits include state and federal income taxes, Social Security and Medicare (FICA), health and unemployment insurance, uniforms and union dues.

When starting a new job your child will be asked to fill out IRS Form W-4, the Employee's Withholding Allowance Certificate. Employers use this form to determine how much income tax should be withheld from your paycheck. The form's instructions help determine how many personal allowances can be claimed.

Note: If you claim your children as dependents and they earn less than \$5,950 during 2012, they

probably won't owe any income tax for the year. If so, they can request that employers not withhold income taxes by claiming an "exemption from withholding" on Line 7 of the W-4. However, if you notice on their year-end W-2 form that the employer did indeed withhold federal and state income taxes, your child must file a tax return in order to get a refund. Self-employed status. Many teens start their working careers by being self-employed, doing parttime jobs like babysitting, yard work or housekeeping. It's important to know that this income is also subject to income tax.

If their self-employment net earnings exceed \$400 in 2012, your kids also must pay self-employment tax, even if they owe no income tax. This tax is similar to the Social Security and Medicare taxes that get withheld from regular wages. Self-employment tax is assessed at 13.3 percent of net self-employment income reported.

The IRS provides a handy guide called "Taxable Income for Students" guide that explains what types of income are and are not taxable (www.irs.gov). For example, tips, bank account interest and certain scholarship-paid expenses (such as room and board) must be reported as taxable income.

IRA contributions. Retirement is probably the last thing on your teenager's mind, but you should know that they are allowed to open and contribute earned income up to \$5,000 to an IRA each year. If you or the grandparents want to make a down payment on your kid's future, consider funding an IRA. For teens it usually makes sense to open a Roth IRA as opposed to a traditional IRA. Here's why:

With a Roth, you pay tax on the contributions that year – and kids are usually in the lowest tax bracket. Then, contributions and investment earnings grow tax-free forever. With a traditional IRA, you make pretax contributions but pay income tax on withdrawals at retirement – usually at a much higher tax rate.

If someone opened a Roth IRA at age 16 and contributed only \$1,000 a year, the account could be worth over \$300,000 by age 60. Sit down with your kid and play around with the Roth IRA Calculator at www.dinkytown.net – it's a great way to teach the importance of compound earnings.



Seeing the Glass Half-Full

For most people, the carefree days of childhood were filled with good times with friends and family free from excess worry and

But as people grow up, most trade the innocence of childhood for worries about finances, their family's health, job security, politics, the economy and environment, and their children's future. Still, a pervasive sense of optimism guides, protects and inspires all of us. Some scientists would even go so far as to say that human beings are hardwired for hope.

By definition we are planners. We have savings accounts, we service our cars before winter, we plan vacations, and we buy green bananas. Planning is a form of cognitive time travel. We forecast how we're going to feel about something by planning ahead. How can we live a healthier lifestyle? What do we need to do to save for retirement? How can we free up more time to do more of the things we want to do? All of these things require the ability to imagine the future by painting a rosy picture in our minds.

A positive attitude has long been linked to better mental health, but in the last few years, a person's optimistic nature has also shown to be beneficial for a person's physical health.

Did you know heart disease patients are more apt to survive a heart attack or heart surgery if they have a positive outlook on life?

Researchers at Duke University Medical Center surveyed over 2,800 heart disease patients regarding how optimistic they felt about their illness. They were asked if they thought they would successfully recover and then be able to return to their regular daily life.

The researchers followed the patients for 15 years after which 1,637 had died. The majority (885) of the patients had passed away from heart disease. But there was encouraging news, too. The patients who had an optimistic outlook were 30 percent less likely to die during the 15year period.

Duke University researchers also found that pessimism was linked to noorer health— which factored similar patients with severe heart disease, age, income, gender and support from family and friends.

The study concluded that a patient's optimistic outlook has a direct correlation not only on the outcome of their disease but also how successfully they will transition from being a heart disease patient to returning home and having a productive daily routine.

But there's a small wrinkle in the optimism studies and that is this: Tali Sharot, Ph.D., a neuropsychologist at University College London, has said that when the brain foresees the future as being better than the past, it's called "The Optimism

That was the basis for a new study which found that the brain sometimes is overly optimistic. Like the song lyrics, "Don't worry, be happy" the study suggests the brain often picks and chooses which optimistic message to listen to. For example, even though people know the divorce rate is 50 percent; they don't feel they will be one of the unfortunate statistics. Or, they see an ad campaign that says smoking can cause severe health problems, but their brain ignores the message. Instead, the brain sends out a message that says that smoking can certainly cause health problems, but those problems are more apt to be linked to other smokers.

What should we take away from this study in our everyday life? A combination of optimism and realism may be the smartest combination of all. Envisioning a better tomorrow relies partly on the hippocampus, the part of the brain that is crucial to memory. Science has confirmed that as human beings we are programmed to be hopeful, but it's also important to be realistic.

So plan ahead, work hard and enjoy the world around you. Live life to the fullest with a combination of optimism and realism, and chances are you'll reap the rewards of better health. Buy green bananas to enjoy in the future, but keep an umbrella in your car, just in case the weather unpredictably changes.


