Governor Cuomo Issues Consumer Tips to Help Protect Against Financial Exploitation of the Elderly

On World Elder Abuse Awareness Day, the Governor advises older Americans, their caregivers and service providers on steps to guard against financial scams

Governor Andrew M. Cuomo today urged older Americans, their caregivers and service providers in New York to guard against various forms of elder financial exploitation. Today is World Elder Abuse Awareness Day – a global day dedicated to elevating the visibility of elder abuse and neglect. To view the consumer tips issued by the Governor, please visit here.

“This administration will not tolerate those who seek to prey on older New Yorkers for financial gain,” Governor Cuomo said. “Learning the facts and how to spot red flags will help safeguard against this particularly repugnant form of exploitation and I encourage older residents and their loved ones to stay informed and help us crack down on elder financial exploitation.”

Benjamin M. Lawsky, Superintendent of Financial Services, said, “Older Americans are unfortunately an especially vulnerable population for financial exploitation. We remain committed to helping root out these scams and protecting older Americans and their families.”

Elder financial exploitation is the illegal or improper use of an elderly adult’s funds, property, or resources by another individual. Recent studies have found that elder financial exploitation is the most common form of abuse facing the elderly, causing significant financial losses and suffering for elderly individuals

and their families. A 2011 MetLife study estimated that financial exploitation costs seniors living in the U.S. at least \$2.9 billion every year. Further, a 2010 survey by the Investor Protection Trust estimated that 1 in 5 Americans over age 65 has been victimized by financial fraud, a startling statistic underlying the pervasiveness and urgency of the problem.

Today's consumer tips address how to prevent three primary categories of financial exploitation schemes that target seniors:

- 1) Scams, wherein a fake offer, alert, or emergency is used to manipulate an elderly consumer into giving money;
- 2) Abuse by trusted persons, such as caregivers, friends, or others in positions of trust with the elder;
- 3) Financial products or services that may be harmful and unsuitable for the elderly, such as certain investments or annuities.

The tips also address signs of diminished financial capacity in elderly consumers and warning

signs of financial abuse to improve detection and prevention.

If you suspect that an elderly person may be a victim of financial exploitation, you should contact the authorities, including Adult Protective Services. Adult Protective Services units are administered by the New York State Office of Children and Family Services, and are located in every county in the state. They are authorized to investigate suspected financial exploitation of vulnerable adults and intervene as appropriate.

The action today by the Governor is part of an ongoing effort to protect elderly New Yorkers from financial exploitation. In January of 2013, Superintendent of Financial Services Benjamin Lawsky adopted New York Insurance Regulation 199, which protects elderly consumers from misleading and fraudulent senior-specific

certifications and professional designations in the solicitation, sale or advice made in connection with a life insurance policy or annuity contract. In July of 2013, Superintendent Lawsky adopted New York Insurance Regulation 187, which sets forth suitability standards and procedures for agents and brokers when making recommendations for annuity contracts to consumers.

Most recently, in February 2015, the Department of Financial Services issued regulatory guidance to financial institutions on identifying and stopping elder financial abuse. At the same time, they also sent a survey to a number of banks and credit unions to gather information on the policies those institutions have in place to protect consumers from elder financial exploitation.

1st at Fort Totten. Word of this first annual event, sponsored by Council Member Vallone's office and hosted by the Bayside Historical Society, has spread quickly throughout Northeast Queens and is expected to draw thousands to celebrate a night of fireworks and family fun.

On July 1st, admittance to Fort Totten will begin at 5pm, and the event will feature performances from the MichelleMarie RockBand Camp and Phil Costa & Something Special Band. Guests are encouraged to bring their own blankets, lawn chairs and picnic related items to the event. Vending trucks will be on site with a variety of foods, snacks and beverages including roasted corn, fresh lemonade, funnel cakes and corn dogs. The fifteen minute fireworks show, vis-

ible as far as the Bronx, will begin promptly at 9:15pm.

This is a non-alcohol event. All bags, coolers, backpacks, etc. will be inspected before entering the park. Parking will be available at the Little Bay Parking Lot and along Bell Boulevard west of Fort Totten with additional parking at the Clearview Golf Course (beginning at 5pm) and the Bay Terrace Shopping Center. Shuttles provided by Vallo Transportation will bring guests to and from the offsite parking locations. Due to the number of people expected to attend, guests are encouraged to bike, walk or bus to the event.

"I can't imagine a better way to kick start the summer than with a fireworks show and concert in Fort Totten. For the first time, residents in Northeast Queens won't have to travel far for world class fireworks and I look forward to sponsoring

this event for years to come," said Council Member Vallone. "These types of family events really bring the community together in celebration and I thank everybody who has worked tirelessly to organize the event, as well as everybody who will be working and volunteering on July 1st to ensure everything goes off without a hitch".

"Holding a concert and launching fireworks from the Parade Grounds in Fort Totten will be a historic event. It has never been done before, and we'll be making history on July 1st." said Alison McKay, Executive Director of the Bayside Historical Society. "BHS at the Castle serves as a cultural destination within the Fort Totten Historic District and hosting an Independence Day Celebration right outside our front door is a great way for the community to link the past with the present."

Bill Allowing New Yorkers to Dine With Their Dogs Passes Assembly, Now Heads to Governor's Desk

Assemblymember Linda B. Rosenthal (D/WF-Manhattan) today announced that her legislation to allow New Yorkers to dine with their dogs in outdoor restaurants just passed the Assembly and now heads to the Governor's desk for signature.

"It's a dog-eat-dog world for New York restaurants, and this bill will help to give those that opt in a leg up against the competition, said Assemblymember Linda B. Rosenthal. "Given all the bad news coming out of Albany these days, it's nice to pass something that actually puts a smile on New Yorker's faces."

The bill, which was sponsored in the Senate by Kemp Hannon, Chair of the Health Committee, passed that house unanimously this week. It would give restaurants the opportunity to let

customers bring their dogs into outdoor dining areas, currently prohibited by law, though a common practice throughout New York despite it being illegal.

Social Compassion in Legislation, a California-based animal advocacy group, worked closely with Assemblymember Rosenthal to pass this legislation. The group was responsible for California's successful campaign to legalize dining with dogs in that state several years ago.

The bill also has strong health and safety standards in place and allows local departments of health to regulate the practice as well.

"People have been dining with dogs all over Europe for years and in California for the last year, and to date, these jurisdictions have not seen an increase in dog bites or complaints related to the dogs,"

said Assemblymember Linda B. Rosenthal. "Here in New York City, we already live side by side with our canine family members. This bill addresses public safety while also recognizing that there is a desire among New Yorkers to bring their dogs to dinner."

Allison Hansen, Editor at BrooklynforPets.com, "We are so excited that the Assembly listened to New Yorkers and voted in favor of the Dining with Dogs bill! We can't wait to welcome our canine pals to outdoor dining spaces. It's an amazing step, and we hope Governor Cuomo signs it into law in time to enjoy the beautiful New York City summer!"

This bill would go a long way toward clarifying for the public and restaurant owners the rights of

Rozic Involves Community Boards in All Night Liquor License Applications



Assemblywoman Nily Rozic (D,) announced the passage of legislation she wrote to reform the application process for the “New Year’s Eve” permits that allow businesses to continue serving alcohol from 4 a.m. – 8 a.m. The bill, which is sponsored in the State Senate by Senator Tony Avella (D, IDC-Bayside), passed with overwhelming bipartisan support.

“This bill would ensure that local Community Boards are given advanced notification when an establishment applies for an “all night” permit,” said Rozic. “Requiring the notification would allow the community affected by the extended hours to raise their concerns before the permit is approved.”

Currently, the State Liquor Authority (SLA) requires businesses to notify the local police precinct or county sheriff when businesses submit their applications. Approval of the application means that the business can remain open on any week-day between the hours of 4 a.m. and 8 a.m. Rozic’s bill would include Community Boards in the decision making process by requiring businesses to notify them as well.

“Community Board 7 is extremely happy that this piece of legislation passed the Assembly. When we receive any application for a liquor license whether new

or a renewal, we always reach out to the Fire, Building and Police Departments. This will allow them as well as the affected civic associations to have additional information when making a determination on any liquor license. I would like to thank the Assembly for its passage,” said Marilyn Bitterman, Community Board 7 District Manager.

“Currently, Community Boards do not have an opportunity to make any recommendations for all night permits, as we are not notified. Assemblywoman Rozic listened to the community and brought about change,” said Marie Adam-Ovide, Community Board 8 District Manager.

Rozic added, “Local input is always needed on any issue affecting a neighborhood’s quality of life. I am glad that residents will soon have an avenue to address their concerns.”

The bill now goes to Governor Cuomo to be signed into law.

Crowley Welcomes Court Decision Allowing Sikh College Student to Enter U.S. Military



Rep. Joe Crowley (D-Queens, the Bronx), Vice Chair of the Democratic Caucus and a leader on Sikh American issues in Congress, released the following statement on the decision by the U.S. District Court that Iknor Singh’s adherence to practicing Sikhism, including wearing articles of faith, such as a turban and beard, would not diminish his ability to serve in the U.S. military. Singh, who resides in Queens and is a student at Hofstra University, is seeking enrollment in the U.S. Army’s Reserve Officer Training Corps. Crowley has been a leader in

urging the U.S. military to end its presumptive ban on Sikhs serving.

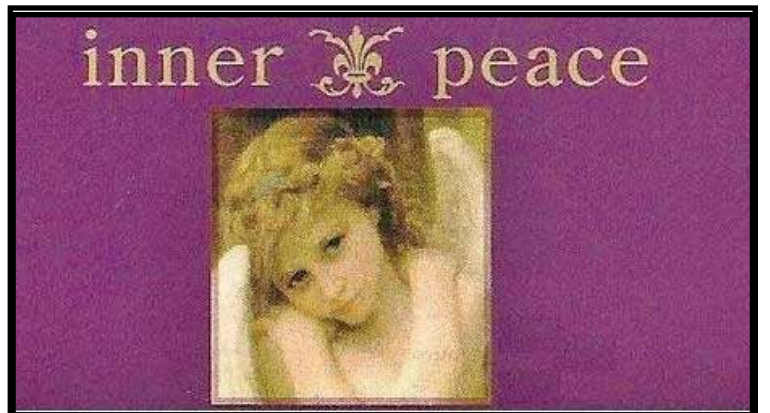
“Time and time again, Sikh American soldiers have demonstrated that it is possible to comply with operation requirements of the military while practicing their faith. The decision by the U.S. District Court is another important step forward in the effort to end the presumptive ban on service by patriotic Sikh Americans once and for all. Sikh Americans love this country and want a fair chance to serve in our nation’s military. It is time for our military to make inclusion of practicing Sikh Americans the rule, not the exception.”

Last year, Crowley and Rep. Rodney Frelinghuysen (R-NJ) led over 100 Members of Congress in a letter to the Department of Defense urging the U.S. Armed Forces to update their appearance regulations to once again allow Sikh Americans to serve while abiding by their articles of faith, such as wearing a turban or beard.

Sikhs have served in the U.S. Army since World War I, and

they are presumptively permitted to serve in the armed forces of Canada, India, and the United Kingdom, among others. Currently, three Sikh Americans have been granted individualized accommodations to serve in the U.S. Army where they have won accolades for their service including the Bronze Star. These patriotic soldiers wear turbans and maintain beards in a neat and conservative manner in accordance with operational requirements. They are also able to wear protective equipment, including helmets and gas masks, in conformity with safety requirements.

A recognized leader in Congress on issues related to the Sikh-American community, Crowley spearheaded a multi-year, successful effort to convince the federal government to begin collecting data on hate crimes committed against Sikh-Americans and Hindu-Americans, an important issue brought to nationwide attention by the massacre of Sikh worshippers in Oak Creek, Wisconsin.

Ronnybrook Farms by Merle Exit

Do you enjoy farm fresh dairy products? Regardless of the sale date, do you really know how many days old is the milk when you first purchase it? Each Sunday, Bill Hosier makes the two-hour long drive from Ancramdale, New York, to the Green Market located in front of a post office in Forest Hills. By 8 a.m. the long line of steady customers has formed for the various dairy products coming from the solar powered Ronnybrook Farms.

Let's begin with some important information. Milk and milk products are said to be the single best source of calcium. Calcium is one of the most essential minerals in our bodies. It promotes the formation of strong bones and healthy teeth in children, and helps older people avoid osteoporosis.

Milk contains the essential proteins that we all need to stay healthy. Protein builds muscle and connective tissue, helps maintain our immune system, and contributes to the health of every organ and system in our bodies.

According to Ronnybrook Farms owner Ronny Osofsky "homogenization is a simple process that can do serious damage to the structure of milk. Large dairy plants have been homogenizing milk for more than fifty years. The process began in earnest when dairy manufacturers stopped using glass bottles and switched to cardboard. Consumers could no longer see the cream line on the milk and when the cream flowed from the cardboard container, many consumers thought the milk was spoiled. Homogenization is a mechanical process which pulverizes the large butterfat globules and breaks them down to micron sized pieces.

Although the product looks "homogenous" and smooth, studies have shown that homogenized milk is not as healthy as non-homogenized milk. Instead of milk fats being digested slowly as they move through the digestive system, the fat is absorbed directly into the blood stream from the stomach.

It simply shocks the system and may act as a toxin. There have been other studies that show that healthful enzymes that surround milk fats may be destroyed when milk is homogenized.

"Many of our customers tell us that Ronnybrook milk is the only milk they can drink without suffering from digestion problems. We strongly believe that non-homogenized milk is simply better for you. It certainly tastes better."

What about yogurt? Ronnybrook yogurts contain live, active and probiotic cultures that strengthen the immune system and promote digestive health while improving the bio-availability of various vitamins, minerals and proteins. For those who are truly lactose intolerant, yogurt is a valuable source of calcium. One cup of yogurt provides nearly 20% of the recommended protein for the average adult male.

"We raise all of our own cows," Ronny says. "We feed them with feed grown almost exclusively on the farm. We milk them, manufacture the various Ronnybrook products and then deliver a good portion of them to our patrons in our own trucks. By concentrating our distribution in the northeast region, our milk moves from cow to table in a little more than a day and there are no artificial growth hormones."

Back at the Green Market, Bill bring a truck load variety of Ronnybrook products. Milk: Chocolate Milk, Chocolate Low Fat, Coffee Milk, Lowfat Milk, Nonfat Milk, Heavy Cream, Half & Half, and Egg Nog. Milk comes in both bottles and plastic containers. Chocolate milk is soooooo delicious and thick without any thickening additives.

Drinkable Yogurt: Plain, Peach, Strawberry, Blackberry, Mango, Banana, Low Fat Blueberry Pomegranate, Low Fat Honey Vanilla. Bill loves the strawberry. I have tried the mango and blueberry pomegranate. Had to get used to a

mango drink not being tart.

Yogurt cups: Coconut, Peach, Strawberry, Vanilla, Maple Vanilla, Plain (Nonfat). Bill loves the strawberry.

Old Fashioned ice cream made on the farm with milk and cream from our own cows. Rich and creamy, our ice cream is 16% butterfat made with the finest hand selected seasonal ingredients. Strawberry, Lola's Mint Lace, Raspberry, Hudson Valley Vanilla, Sid's Chocolate Silk, Chocolate Chip, Columbia County Coffee, Ginger Creme Brûlée, Coconut, Toasted Hazelnut Crunch, Chocolate Hazelnut, Butter Pecan, and Blueberry.

Their butter is fresh churned in small batches at our creamery. It is rich and creamy with 84-86% butterfat content. In addition to the salted and unsalted, our flavored butters are garlic and cinnamon. Ronnybrook butter is churned in 40 gallon batches which produces a higher butter fat content and allows for very little moisture. Bill said the cinnamon is the least demanded. I have made French Toast using the butter in the pan and it is better than syrup! Ronnybrook Creme Fraiche is made from 40% cream, slightly tangy, slightly nutty thickened cream. I have used it in place of sour cream mixed with avocado as well as on fresh fruit.

What about the cost? You are getting the best and freshest dairy products by going to the Green Market. Ronnybrook products are sold elsewhere. I compared the Green Market prices with those of Fresh Direct and Pea Pod two delivery companies that had some variety of their products. The prices at the Green Market were less expensive.

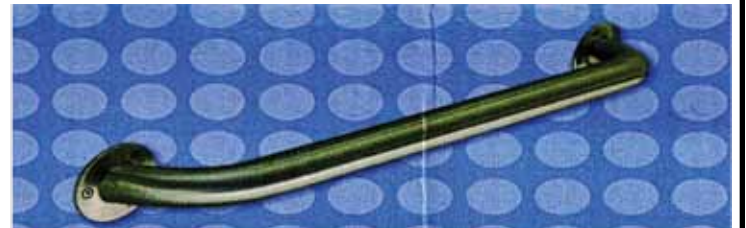

Assembly Passes Braunstein’s Bill Banning “N-Bomb” Drug



Assemblyman Edward C. Braunstein (D-Bayside) announced the passage in the Assembly of legislation banning the synthetic drug known as “N-Bomb” (A.627-A/S.738).

N-Bomb, also known as “Smiles,” first surfaced in 2013, accompanied by reports of overdoses throughout the country. This legislation would ban key ingredients contained in this drug that mimic the hallucinogenic effects of LSD. Because this drug is chemically manufactured, its potency varies widely. As such, it

is difficult to predict how someone may react to the substance. Some harrowing side effects of N-Bomb include seizures, psychotic episodes, loss of consciousness, and bleeding from the brain.

“Just as my 2011 legislation banning bath salts helped to prevent an epidemic in New York, this bill would permanently ban these dangerous chemicals before the problem becomes widespread in our State,” said Assemblyman Braunstein. “These danger-

Senate Passes Gianaris Bill to Crack Down on Dangerous Scofflaw Drivers

The New York State Senate passed Senator Michael Gianaris' bill (S2484A) to crack down on drivers who kill or seriously injure others while driving with revoked, suspended or otherwise invalid licenses. The bill would make such an event a felony and is included in Mayor de Blasio's Vision Zero agenda. Assemblywoman Marge Markey carries both bills in the State Assembly.

"I am glad the Senate passed my proposal to get tough on dangerous drivers. We must crack down on drivers who should not be on the road before the next tragedy occurs, not after," said Senator Gianaris. "Too many families have grieved at too many vigils, and too many pedestrians have died because of these bad drivers. I urge the Assembly and Governor Cuomo to follow suit and enact my proposal into law immediately."

Paul Steely White, Executive Director of Transportation Alternatives, said, "Unlicensed drivers are among the most dangerous on our roads -- a person driving with a suspended license is twice as likely to cause a fatal crash. This legislation sends a powerful message that New Yorkers will no longer allow unlicensed drivers to wield the deadly weapon of an

automobile on our streets. Thanks to Senator Gianaris' leadership, prosecutors would soon have more tools to bring about much-needed driver accountability in the Vision Zero era."

"This important bill is about accountability for unlicensed and chronically reckless drivers who injure or kill people," said Cristina Furlong of Make Queens Safer. "We hope that the risk of steep consequences deter these dangerous drivers from getting behind the wheel in the first place. Now more than ever, we are grateful to Sen. Gianaris for his leadership on this issue and all of those that affect pedestrian safety."

Senator Gianaris, a longtime advocate for safer streets, first introduced this bill after a truck driver without a valid license struck and killed Noshat Nahian, a 3rd-grader at PS 152 in Woodside on his way to school on Northern Boulevard in December 2013. Senator Gianaris renewed his call for these measures after Angela Hurtado was killed by a driver with a suspended license in Maspeth in January 2014. Most recently, Senator Gianaris implored his fellow state legislators to act on these measures after a pedestrian was killed by such a driver on Woodside Avenue in February.

Bipartisan Coalition of Lawmakers Urge President Obama to Award Yogi Berra the Presidential Medal of Freedom

Ahead of the Annual Congressional Baseball Game, U.S. Reps. Bill Pascrell, Jr. (D-NJ), Tom Marino (R-PA) and Joe Crowley (D-NY) led a bipartisan coalition of thirty-six lawmakers in urging President Obama to Award Yankees legend Yogi Berra the Presidential Medal of Freedom. In a letter to President Obama, the lawmakers cited the former Yankees' many accomplishments on and off the field as reason to award Berra the highest civilian award of the United States.

"As a strong advocate for civil rights during a time when Major League Baseball was embracing the first black and Latino players,

Berra had an a profound impact in the baseball community and across America," the lawmakers wrote. "Over the years we have watched proudly as Berra brought the Yankees numerous victories, continued his leadership as a manager of both the Yankees and Mets, and fought for priorities that bring out the best in our country. As a champion and hero in more ways than can be counted, Berra is an American icon who is deserving of the Presidential Medal of Freedom."

Earlier this week, supporters were successful in obtaining more than 100,000 signatures on a whitehouse.gov petition urging support in bestowing the Presiden-

tial Medal of Freedom upon Berra, surpassing the threshold needed to require an official response from the White House.

Rep. Pascrell first urged President Obama to award Berra the Presidential Medal of Freedom last month in recognition of the Yankees legend's 90th birthday.

The Annual Congressional Baseball Game, scheduled for this evening at 7:05pm at Nationals Park, brings together lawmakers from both sides of the aisle in a showdown to raise funds for The Washington Literacy Council, The Boys and Girls Club of Greater Washington, and the Washington Nationals Dream Foundation.

Crowley Statement on 52nd Anniversary of Equal Pay Act Calls for immediate passage of the Paycheck Fairness Act

Rep. Joe Crowley (D-Queens, the Bronx), Vice Chair of the Democratic Caucus, released the following statement marking the 52nd anniversary of the Equal Pay Act. Crowley is a co-sponsor of the Paycheck Fairness Act, which strengthens the Equal Pay Act and helps to ensure women everywhere will earn a fair day's pay for a fair day's work.

"Equal pay is not just a women's issue – it's a family issue. When the Equal Pay Act was signed into law, women were earning only 66 cents for every dollar a man earned. While that gap has narrowed, the fact that it continues to exist is astonishing. We must renew our commitment to ensuring all workers are treated equally and pass the Paycheck Fairness Act. Our mothers, sisters, wives, and daughters all deserve better."

The Equal Pay Act, signed into law June 10, 1963 by President John F. Kennedy, requires employers to give women and men equal pay for equal work. At the time the bill was signed, women were paid 66 cents for every dollar earned by men. Today, 52 years later, women on average make 77 cents for every dollar earned by men. According to a Pew Research Center analysis four in 10 American households with children under the age of 18 include a mother who is either the sole or primary earner for her family.

The Paycheck Fairness Act strengthens and closes loopholes in the Equal Pay Act, including by providing effective remedies to women who are not being paid equal wages for doing equal work and by protecting employees from retaliation for sharing salary information with their co-workers.

Assembly Passes Braunstein's Bill Banning "N-Bomb" Drug

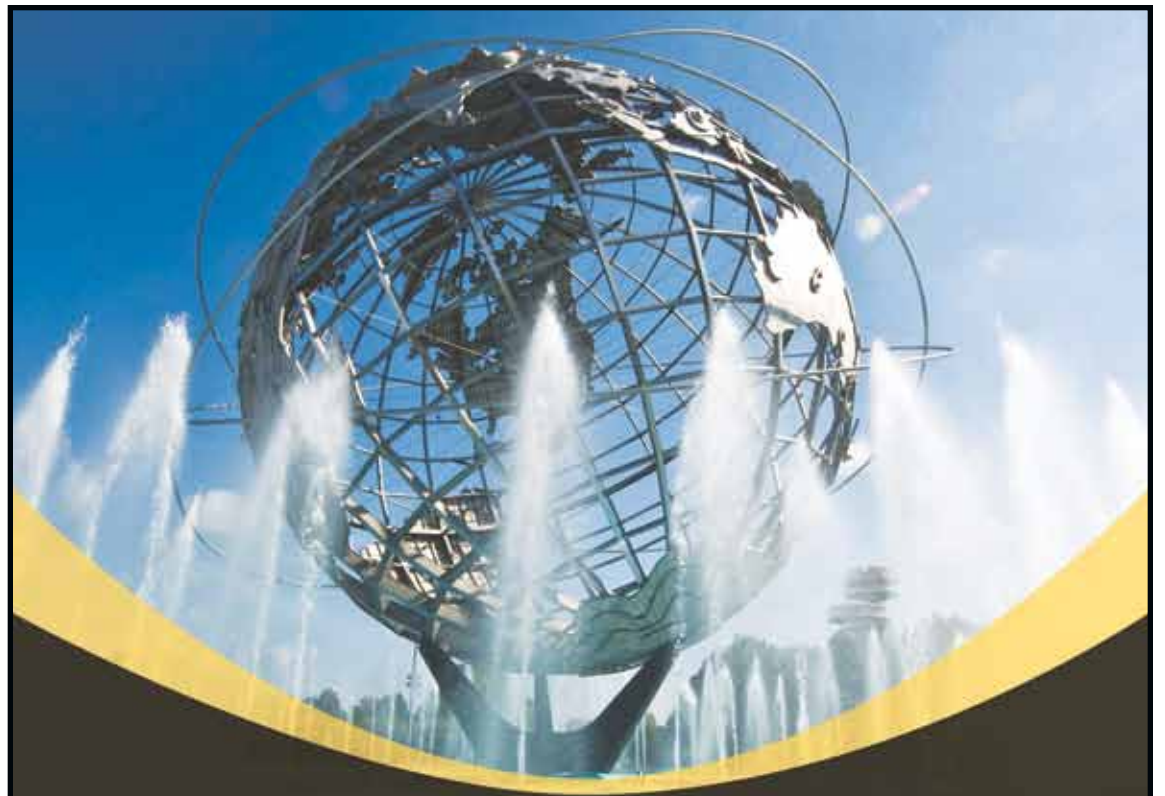
