and were joined by General and Legislative Counsel of NYC Hospitality Alliance Robert Bookman, Executive Director of NYC Hospitality Alliance Andrew Rigie and Jerry's Café owner Leonard de Knecht.

In 2010, the Department of Health and Mental Hygiene (DOHMH) introduced a letter grading system with the worthy goals of assisting the public to make informed decisions about where to dine, improving restaurant compliance with health and safety regulations, and reducing food-borne illnesses attributable to restaurants. Since the introduction of letter grading, however – which caused an increase in the frequency of inspections

– restaurants raised concerns about the system to the Speaker and Council Members in meetings and at forums, through the Council's citywide Restaurant Inspection Survey and during a March 2012 oversight hearing of the DOHMH. Principal among the issues raised by restaurateurs, advocates and experts were the increased fine burden on restaurants since the introduction of the letter grading system, inconsistencies across inspections and frayed and adversarial relations between DOHMH and restaurants.

Specifically, this new legislative package will address many of these concerns and result in: Across the board fine reductions; Fine waiver for restaurant owners/operators who contest

an initial inspection's findings at the Administrative Tribunal and ultimately receive an A; The opportunity for restaurant owners/operators to request a consultative and ungraded inspection for educational purposes; Establishment of an ombuds office to receive and address comments, complaints and compliments; Development of an inspection code of conduct pamphlet that inspectors will distribute to all restaurant owners/operators prior to the beginning of an initial inspection; Creation of an advisory board to ensure ongoing and systemic review of the restaurant inspection program; Increased and improved reporting of restaurant inspection data; and Relief from violations relating to the physical layout or structure of a restaurant

## Time Warner Cable Launches Lifeline Program For Home Phone Customers In New York State

Time Warner Cable has launched the Lifeline program for Home Phone customers throughout New York State. Lifeline is a government-assistance program, part of the Federal Communications Commission, which grants eligible individuals per household a monthly credit on their residential Home Phone bill. Eligible customers can now apply for the Home Phone discount beginning July 9.

To be eligible for Lifeline, you must be a Time Warner Cable Home Phone customer and participate in a government-assistance program, such as Medicaid or Food Stamps, or meet income eligibility requirements. The Lifeline credit applies for one

year. After one year, customers will need to verify their information and continued eligibility.

"Lifeline allows consumers the opportunity to get a monthly discount, so that they can access and experience Time Warner Cable's Home Phone services and features," said Jeff Lindsay, Time Warner Cable's Group Vice President and General Manager for Phone. "Home Phone is still a vital communications tool. # Don't Get 'Spoofed' by Rogue Callers

When caller ID first arrived on the scene it seemed like a godsend to many people: Now you could easily identify who was on the line and ignore unwanted calls, whether from telemarketers, an ex-boyfriend or an unfriendly collection agency.

But as often happens, unscrupulous individuals soon began manipulating the technology to defraud people by pretending to be someone else. Their scheme is called "caller ID spoofing" and disturbingly, it's perfectly legal in many cases.

Here's how caller ID spoofing works and what precautions you should take to avoid being victimized:

For a very low cost, businesses and individuals can use widely available caller ID spoofing software to generate calls that alter the telephone number and/or name which appear on the recipient's caller ID screen.

Police, private investigators and collection agencies have used legal spoofing services for many years. Others who might have a legitimate reason to hide their identity when making a call include domestic violence victims and doctors returning patient calls who don't wish to release their private telephone numbers.

Beyond that, the lines of legality begin to blur. The Truth in Caller

ID Act of 2009 prohibits anyone from transmitting misleading or inaccurate caller ID information with the intent to defraud, cause harm or wrongfully obtain anything of value. Violators can be penalized up to \$10,000 for each infraction. Unfortunately, such penalties haven't dissuaded many scammers.

One common scam involves spoofers pretending to represent a bank, government agency, insurer, credit card company or other organization with which you do business. They count on you being reassured after recognizing the company's name on your screen.

Under the pretext of warning about an urgent situation (breached account, late payment, pending insurance claim, missed jury duty summons, etc.), the spoofer will try to coax you into revealing personal or account information, supposedly to verify their records.

Often these are robocalls, where a recorded voice asks you to stay on the line to speak to a representative or call another number for more information. Do not. If you suspect the call might possibly be genuine, contact the company yourself at the toll-free number found on your card, account statement or the company's website.

You should never reveal your full Social Security number, mother's maiden name, credit card number, passwords or other

private information over the phone unless you initiated the call yourself. Someone possessing such information could use it to gain access to your existing accounts to withdraw or transfer money, raise credit limits or snoop around your recent activity, among other intrusions.

ID thieves also can use your personal information to open new credit accounts (e.g., credit cards, mortgage or car loan), create a new identity or even obtain a job fraudulently. Often, you won't even realize something's wrong until a collection agency – or the IRS – starts hounding you for unpaid bills or taxes.

Another common caller ID spoof involves hacking into someone's voice mail account. Many cellphone users never bother to set up passwords on their voice mailboxes. And, since many voicemail systems grant access to callers phoning from their own number, a hacker could easily spoof your number and gain access to your messages.

Bottom line: You wouldn't give your personal information to a stranger on the street. Take the same level of precaution with strangers on the phone – or online.

# New York Hall of Science Presents Tesla's Wonderful World of Electricity

Special Exhibition Explores the Life and Legacy of a Scientific Icon

In collaboration with the Nikola Tesla Museum of Belgrade, Serbia, the New York Hall of Science (NYSCI) presents a new exhibition, Tesla's Wonderful World of Electricity. The exhibition opens on July 10, 2013—a date celebrated around the world as Nikola Tesla Day—and will run through October 20.

Tesla's Wonderful World of Electricity presents working models of the late scientist's inventions, models of his laboratories and plants, photographic reproductions and a narrative about Tesla's life and work.

Tesla's inventions—he held nearly 300 registered patents in 26 countries—are still integral to today's home appliances, industrial plants, and factories. His contributions range from his most significant invention—the alternating current (AC) motor—to x-rays, remote controls and fluorescent lighting.

Tesla contributed to machine engineering with his original solutions for bladeless turbines and pumps, applying his novel principle of providing propulsion through fluids. He patented solutions in the field of speed meters and ventilators, and worked on

the construction of various types of fountains. His patent for an aircraft with vertical takeoff and landing combines the features of an airplane and a helicopter—an idea that was not realized for another several decades.

"It is impossible to measure the significance of Nikola Tesla's influence on our modern world," said Margaret Honey, president and CEO of NYSCI. "He was ahead of his time in countless ways and yet he was a quintessential hero of his era: visionary, multi-talented and eccentric. His legacy persists in the numerous devices and technologies that were made possible by his innovations."

"Tesla was a man graced with inspiration, incredibly broad scientific knowledge, enormous energy, courage, patience and persistence," said Vladimir Jelenkovic, Director of the Nikola Tesla Museum. "His visionary creativity paved the way for our lifestyle of today, fundamentally underpinned by the distribution of electrical power over great distances as well as the wireless world of communication."

Tesla's Wonderful World of Electricity consists of photographs and documents of major events in

Tesla's life, including his heritage and family, professional career, his contributions to various scientific fields, and some of the awards and recognitions he received throughout his life.


The exhibition also includes models of his facilities as well as several of his most significant inventions. Among the items represented are induction motors with egg-shaped and disc-shaped rotors, a Tesla coil, Tesla's pump with computer-animated working principles, a model of the Adams' power station on the Niagara River, a model of Tesla's laboratory in Colorado Springs, and a model of Tesla's airplane with vertical takeoff and landing capability.

The legend of Tesla has made him a mythical figure and hero to inventors and tinkerers everywhere, yet the major contributions of Tesla's research and innovations remain relatively unknown compared to the household names of Edison or Westinghouse.



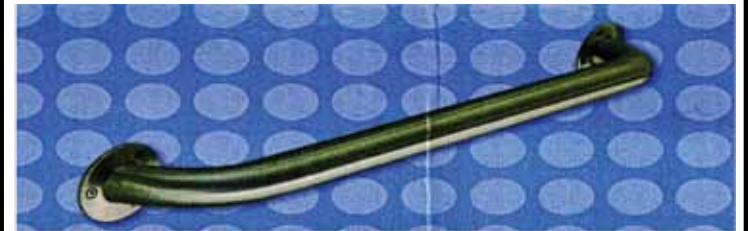

## World's Smallest Deer Born At The Wildlife Conservation Society's Queens Zoo

An endangered southern pudu, (Pudu puda), the world's smallest deer, was born at the Wildlife Conservation Society's Queens Zoo. The young doe weighed 1 pound at birth; could weigh as much as 20 pounds as an adult.

The fawn is still nursing but will soon transition to fresh leaves, grain, kale, carrots and hay.

Pudu have extraordinary characteristics: they will bark when they sense danger and can climb fallen trees. Although small in stature, only 12 to 14 inches at the shoulder, pudu are excellent jumpers, sprinters, and climbers. What the pudu lacks in size, it makes up in strategy. When chased, pudu run in a zig-zag pattern to escape predation.

Southern pudu are native to Chile and Argentina and are designated vulnerable by the International Union for Conservation of Nature (IUCN). Using research and conservation practices, WCS is working in the pudu's range countries to grapple with habitat loss and other threats to wildlife.

The Wildlife Conservation Society saves wildlife and wild places worldwide. We do so through science, global conservation, education and the management of the world's largest system of urban wildlife parks, led by the flagship



Bronx Zoo. Together these activities change attitudes towards nature and help people imagine wildlife and humans living in harmony. WCS is committed to this mission because it is essential to the integrity of life on Earth.

## CM Gennaro Warns Residents to Take Precautions Against West Nile Virus



Council Member James F. Gennaro (D-Fresh Meadows) urged residents – particular the elderly

and those with weak immune systems – to take simple steps to protect themselves and their families after the City's recent discovery of mosquitoes infected by the West Nile Virus in Pomonok.

"With the discovery of West Nile Virus for the first time this season, I want to remind everyone to take precautions against mosquito bites," Gennaro said. "That includes using mosquito repellent and to cover your arms and legs at dawn and dusk."

The infected mosquitoes were detected in the past week by the City's Health Department in Pomonok and the Huguenot section of Staten Island.

West Nile Virus can cause serious health complications, including neurological disease, as well

as milder complications such as flu-like symptoms with headache, fever and fatigue.

The Health Department issued the following tips to reduce exposure to mosquitoes:

- Use an approved insect repellent containing DEET, picaridin, oil of lemon eucalyptus (not for children under 3), or products that contain the active ingredient IR3535.
- Make sure windows have screens to keep mosquitoes out of your home, and repair or replace screens that have tears or holes.
- Eliminate any standing water from your property since it provides a breeding site for mosquitoes, and dispose of containers

June 11th, Day 5. The rains continue as we head to yes, another lake; this one being Raquette Lake, the location of Great Camp Sagamore. Timing and not being forewarned would have helped as I was attacked by small black flies the moment I got out of the car. Had I known I would have waited for our tour guide to greet us with a net hat! Part of the tour takes you to the work buildings, such as where they make items that relate more toward the needs of the "resort" vs. a silversmith that might be making horse shoes...there are no horses here. You can then get a tour of the buildings that house the accommodations along with the recreation areas.

The furniture known to us as Adirondack Chairs are said to have been created to ease the suffering of those who had tuberculosis. I wonder if the makers of that penal code are aware.

As this is a "great camp", don't expect to be staying at a hotel with all of the amenities. No smoking, no pets, no maid service, no telephones in the rooms or cell service, no tv and no hard liquor. Most of the accommodations have shared baths and bunk beds. Hey, this is what sleep-away camp was like several years ago! All meals are served buffet style.

Part of the Sagamore Institute of the Adirondacks, educational programs are the happening. One of them, the Intergenerational Programs is restricted to Grandparents and Grandchildren. Seniors may also take advantage of Road Scholar, a former travel program that seemed to be restricted to staying at hostels. [www.great-camp-sagamore.org](http://www.great-camp-sagamore.org)

To get an even better perspective of Raquette Lake, we scheduled a cruise on the W. W. Durant. Arriving early we first took a tour of the town. There was the following: one general store; on hotel that housed the one restaurant; one gas station (pretty much for boating); the library; post office location in the hotel. Let's not forget the gift shop located just across the way from the W.W. Durant.

The boat cruise is a family owned and run company known as Raquette Lake Navigation, with dad as the captain, son as a bona fide CIA graduate chef, daughters and mom (Donna Pohl) handling everything else. You are given a map to follow the sites (many of which are camps) pointed out by the captain, which were still quite visible from the main deck windows despite the rain. Food is served buffet style with "table

On the way to Wilmington, we stop off to check out Hoss Country Corner in the town of... Long Lake! Next destination is Tupper Lake to visit the Wild Center. I heard about the otter exhibit. This was a must for me...oh. if only I can pet one. As it turns out these particular creatures are sea otters different from the ones that you see lying on their backs and pulling their food apart. Just as cute! Time was spent inside the center with films, a pond with turtles and ducks, a series of fish, and a look at some "wild" history representing that Adirondacks. It is still raining as we check into the Ledge Rock Inn in at Whiteface Mountain. The appearance gives it a two story motel, but

there is a lot more to it. A "Great Room" is a gathering place with amenities that include a big screen tv, movies, board games, and pool table. Outdoors is a pool, bbq areas and some fabulous views of Whiteface Mountain. Rooms are cozy, comfortable and clean with a small frig and microwave. Dinner was at the Hungry Trout in Wilmington about a ten minute drive from Ledge Rock and on Route 86. It is actually a resort with various lodging and a separate restaurant. 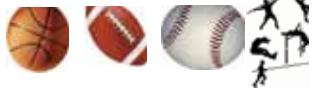

### Heat and Humidity Mark Tourney by Robert Elkin

What a weekend to hold the semi-finals and finals of a tennis tournament!

It happened during the championship matches of the first New York Open in both the Men's Open Singles and Men's Open Doubles. And the tourney drew some of the top players in the men's singles category at the West Side Tennis Club in Forest Hills. The men's singles drew 23 competitors and the men's doubles attracted seven teams.

In a match that had to be stopped numerous times in each of the three sets on the Stadium court because of the sunny, hot and humid conditions last Sunday afternoon top seeded Winston Lin who plays first singles for the Columbia University team, won the first set 6-3, and second seeded Richard 'R.J.' Del Nunzio, who is entering his sophomore year at St. John's University, took the second set also by a 6-3 score. Then the heat got to both players tremendously once again in the third and last set of a best of three set match. Lin lead 3-0 and before the fourth game could even be completed, the referee stopped the action putting a halt to a very good match, possibly showcasing the best there is among the college crop heading toward a pro career.

Despite the weather, the four day tournament was a success for all concerned, including Del Nunzio, who competed in his second tournament since returning 'home'. A resident of Forest

Hills, Del Nunzio attended Oklahoma State University where he played on its tennis team during his freshman year. He then decided to return to the site that he was very familiar with and had a decent following.

R.J. and Lin have a tremendous amount of ability to be great players. R.J. seems to be really on top of his game and is trying to continue where he left off especially while playing in the Juniors.

"They can do very well in college," said Dale Caldwell, who started this tournament to keep building the sport of tennis here in New York. "When they get to the pro level they will be bangers. If they wake up and work on their strength they can do really well. (But today - in the final), this heat was tough. It is the same heat found around the world."

The players agreed that it was tough to play in the heat and humidity.

Meanwhile, in the doubles final played earlier in the day, Jason Speirs teamed with Justin Natale and defeated second seeded George Finch and Richard Del Nunzio, 6-3, 1-6, 7-6, winning the last set on an 8-6 tie breaker in the sunny, humid weather conditions, also on Stadium court.

"It's just a battle to fight the elements," Speirs said. "It's hot out there. We had to stay hydrated. Other than that it's great to play here. We had great opponents and it (the match) was tough. It (the weather) could have been cooler."

"Normally (the referee) doesn't

put doubles in front of singles," Del Nunzio said after the singles final. "I tried to give it my all. (In the singles final) I lost the first set and then tried to get it back in the second. I managed to do it. I knew that at 5-1 when I was winning that I would not relax. I was lucky to hold after 5-3.

"In the third set he (Lin) was up 3-0, and I was down a break and had to retire."

Next on the tennis scene for R.J. is another Men's Open tournament but this one in Virginia, as he is used to travel to compete on the tennis circuit. He happened to be an extremely good junior player, maybe the best in the East at one point.

The tournaments that he will enter into will help prepare him for the remainder of his college career. "They (these matches) are good practices...."

The fans saw some tremendous tennis in the first New York Open and hope to see more in future years. This tournament could conceivably be an annual one, according to Caldwell. The tournament director of the New York Open was the WSTC head pro Bob Ingersole, who is now conducting a summer camp for the youngsters.

Meanwhile Speirs, who is the director of the Roosevelt Island Tennis Club and its head pro, and his staff will conduct their own tennis tournaments, including one for the Men's Open Division in early August. It is a USTA sanctioned event.

### Best of Best Come To Queens by Robert Elkin

Don't forget Tuesday evening Citi Field and the New York Mets are hosting the 2013 and 84th annual all-star baseball game, featuring the best from the National League and their counterparts from the American League. And who else but David Wright of the Mets heads the roster for the National League.

The last time that the Met played host to such a attraction came back on July 7, 1964 and

50,000 fans turned out at the then Shea Stadium.

Such a game dates back to 1933. The National League captured the last three mid summer attractions with the American League being shut out last year.

Yankee veteran relief pitcher Mariano Rivera, retiring after this season is over, said, "it's wonderful to be named an all-star again, especially with the game being here in New York.

New York fans are the best and they deserve it. I know that they will put on a show and hopefully, we'll be a good job."

"It feels great (to be an all-star)," noted teammate Robinson Cano. "I want to thank the fans that dedicated their time to vote for me to start the game. I can't tell you how much I appreciate it. There are a lot of great second basemen in the American League...."

Bloomberg estimates the game will have a \$191.5 million impact on New York City's economy, attracting 176,000 visitors to the city and generating a television audience of more than 30 million viewers.

Voting for starting players was originally done with paper ballots distributed at all Major League ballparks. Internet voting was added in the late 1990s, allowing the vote to go global and expanding it from 400,000 ballots in 1998 to 34.9 million votes in 2012.

The \$850 million Citi Field was an idea that came after New

York City's bid to host the 2012 Olympic Games. If New York had won the bid, Citi Field would have been expanded to host Olympic events and the Mets would have played the 2012 season at the Yankee's Stadium.

The MLB will donate more than \$1 million combined to the Robin Hood Relief Fund and the Mayor's Fund to Advance New York City, two organizations helping victims of Hurricane Sandy, as part of All-Star Weekend. On top of this donation, funds raised at the All-Star 5K & Fun Run and the MLB All-Star Charity Concert will benefit Sandy relief.

### NYS Department of State's Division of Consumer Protection Warns Consumers of Time-Share Resale Scams

The New York Department of State's Division of Consumer Protection warns consumers looking to sell a timeshare property to be wary of scams by companies charging up-front fees and guaranteeing that it will be sold.

In the last year, the Division of Consumer Protection's Consumer Assistance Unit has received over 30 complaints from consumers about timeshares. Many of these complaints are from consumers who paid an upfront fee to a company promising to sell their timeshare. By the time the consumer tries to contact the company to confirm the sale of the property, the company has disappeared.

Dishonest companies contact property owners and mislead them with an offer to help to sell their vacation properties. Posing as an agent or broker, the person will produce an appraisal or offer a very generous bid for the timeshare or vacation property. Before the sale is finalized, the consumer will be told that he or she owes taxes or administrative fees. Once the owner provides his or her financial information and paid the "fees" or other charges, the broker or agent will vanish without a trace.

Tips When Attempting to Sell a Timeshare Property:

- Beware of Unsolicited Offers- Avoid doing business with companies or individuals that contact you by mail, over the phone or via electronic mail.

- Licensing Requirements- Ask if the company's salespeople are licensed to sell real estate where your timeshare is located. If the property is in New York, verify this with the New York Department of State's real estate broker license data base at [www.dos.ny.gov](http://www.dos.ny.gov).

- Do Not Pay Upfront- Do not deal with companies that charge up-front fees of any kind.

- Avoid Money Back Offers- Be cautious of any company which offers a "money-back guarantee" that your timeshare will be sold, particularly within a set period of time.

- Do Not Pay in Cash. Do not pay by cash or wire transfer.

- Check References- Do your research before transacting business with any company and compare their offers to industry competition.

Governor Andrew M. Cuomo announced today that MTA Long Island Rail Road will provide extra train service direct to Citi Field during Major League Baseball's All-Star Game and related festivities on Sunday, July 14, Monday, July 15, and Tuesday, July 16.

## Cuomo Signs Legislation Creating New Penalties For Texting-While-Driving For Young And New Drivers

Governor Andrew M. Cuomo today signed legislation that creates new penalties for texting-while-driving for young and new drivers to better protect New Yorkers on the road.

"Today's new law sends a powerful message to our young and new drivers that texting-while-driving will not be tolerated here in New York State," Governor Cuomo said. "Statistic after statistic shows that texting-while-driving is a chronic problem in our society, particularly among teenagers, and it will only get worse if we do not take action to prevent this deadly behavior. That is what this law will do: it will make drivers of all ages think twice before taking their eyes off the road to answer a message on their phone. It will avoid loss of life and better protect all those traveling on our roads and highways. I thank my colleagues in the Legislature for their expeditious action on this bill. Together, we are making our communities safer for all."

Currently, probationary and junior licenses are suspended for 60 days for violations such as speeding, reckless driving, or following too closely behind another vehicle. Such licenses are revoked for 6 months (for probationary licenses) or 60 days (for junior licenses) if there is another violation within 6 months of the license being restored.

The new law signed by the Governor today imposes the same penalties on drivers with probationary and junior licenses for texting-while-driving and using a hand-held cell phone that they now receive for speeding and reckless driving: 60-day suspensions for first convictions and revocations of 60 days (for junior licenses) or 6 months (for probationary licenses) for subsequent convictions within 6 months of the time a license is restored after suspension. This is effective immediately.

Senator Carl Marcellino said, "The image of a teenager spending hours talking on the phone is disappearing and it's being replaced by the image of a teenager hunched over texting. It is second nature to young people. They do it all the time and when the day arrives that they get that all important driver's license, they do not stop. The statistics are alarming and deadly, and avoidable. Under the Governor Cuomo's leadership, we are giving New York some of the toughest laws on texting while driving in the nation. I thank him for working across the aisle to

implement this landmark law that will save lives and will also set an example for other states."

Assemblyman David Weprin said, "As a staunch advocate for consumer and driver's safety, the health and safety of all New Yorkers takes primary importance for me. I cosponsored Assembly Bill 7739 because cracking down on texting-while driving will prevent accidents in New York State that are avoidable."

New York State Police Superintendent Joseph D'Amico said, "The number of distracted driver related crashes have been steadily increasing which is why this law is so important. The New York State Police are committed to reducing distracted driving through a combined enforcement and education effort. This law will help deter cell phone use which will lead to fewer accidents and will help to save lives."

John A. Corlett, Legislative Committee Chairman for AAA New York State, said, "By signing this bill into law, Governor Cuomo is sending a strong message to drivers all across the state that texting-while-driving will not be tolerated in New York. Traffic crashes remain the leading cause of death and injury for teens, and surveys show that texting is even more prevalent among young and new drivers. This risky, selfish behavior poses a danger to everyone on our roads, and AAA strongly supports the strong deterrents put in place by this law. I applaud the Governor for leading this effort, which will help ensure that the attention of New York's drivers is focused where it should be: on the road and not on cellphones."

Ben Lieberman, Co-Chair of Distracted Operators Risk Casualties, who lost his son in a car crash, attended today's bill signing.

Ben Lieberman said, "Having experienced firsthand the horrible consequences caused by a distracted driver, I know that you don't need an academic study to prove that taking your eyes off the road means you are more likely to crash. Smartphones have more tempting features than ever before. Texting while-driving and these other distractions are extremely dangerous and we need to curb this behavior, which continues to cause traffic casualties day after day. Governor Cuomo's new law will help deter this dangerous habit, and I am grateful for his efforts. I also applaud the Legislature for their quick action on this bill."



### Van Bramer & Edie Windsor March In The New York City Pride Parade
