### Attorney General James Issues Consumer Alert to Protect New Yorkers From Dangerous, Fake COVID-19 Vaccination Cards

New York Attorney General Letitia James today issued an alert to protect New Yorkers from the dangers of fake coronavirus disease 2019 (COVID-19) vaccination cards. The sale or distribution of blank or fraudulently-completed vaccination cards to individuals who have not actually received a vaccine poses a serious threat to the health of New York communities, and will impede the progress that has been made in combatting COVID-19. Falsifying vaccine cards and records, as well as the unauthorized use of the Centers for Disease Control and Prevention (CDC) and the U.S. Department of Health and Human Services' (HHS) seals, also violate various federal and New York state laws and is subject to civil and criminal enforcement.

"As the Delta variant becomes more prominent, it is more important than ever for New Yorkers to be vaccinated against COVID-19," said Attorney General James. "Not only do fake and fraudulently-completed vaccination cards violate federal and state laws and the public trust, but they also put the health of our communities at risk and potentially prolong this public health crisis. I strongly urge New Yorkers to reject these fake vaccination cards and get the COVID-19 vaccine, so that we can move forward from this pandemic and return to normalcy as soon as possible."

COVID-19 vaccines are now available to all New Yorkers 12 years of age and older, and must be administered free of

charge. To find a New York state operated vaccination site, please visit this the state's COVID-19 vaccine tracker website. Other vaccination sites can be found online.

Legitimate CDC vaccination cards are provided to individuals once they receive the COVID-19 vaccine. If an individual receives the Pfizer or Moderna vaccines — which require two doses — they will receive a vaccination card after their first dose that will be updated after the second dose. Those getting the Johnson & Johnson vaccine will receive their vaccination card after their single dose. New Yorkers are urged not to share pictures of this card online or on social media, or to at least blur out private information (date of birth, vaccination lot number, etc.). Scammers can use New Yorkers' personal information to steal their identity, and use pictures to create fake cards.

New Yorkers can access proof of a COVID-19 vaccination or a negative test result digitally on

their smartphone using one of the two Excelsior Pass apps, which are available for free from the Apple App Store and the Google Play Store. Use of the Excelsior Pass apps are voluntary, and with these apps, New Yorkers can easily retrieve and store a digital form of vaccine records or negative test results and avoid misplacing or damaging their vaccination card. New Yorkers can learn more about the Excelsior Pass apps online.

Relatedly, this past April, Attorney General James and a bipartisan coalition of attorneys general sent letters to a number of companies asking them to act immediately to prevent the sale of fake COVID-19 vaccination cards on their platforms.

Separately, last week, Attorney General James, leading a coalition of advocates, sent a letter to Facebook, urging the company to address and dispel harmful and inaccurate myths about the COVID-19 virus and the available vaccines on its platform that have targeted Latino communities. This letter came after Attorney General James and a coalition of

attorneys general sent an earlier letter to both Facebook and Twitter, in March 2021, calling on the companies to enforce company guidelines against vaccine misinformation.

In April, Attorney General James issued an alert urging New Yorkers to report unlawful vaccine charges as the vaccines are and always have been free of charge.

Lastly, in March, Attorney General James issued an alert to New Yorkers to beware of scams making fraudulent promises to consumers that they could cut COVID-19 vaccine lines or receive additional stimulus payments. This alert followed an earlier alert, in December 2020, where Attorney General James warned New Yorkers about potential scams offering early access to the COVID-19 vaccine.

Any New Yorker that believes they have been a victim of a COVID-19 vaccination card scam should contact the Office of the Attorney General by calling 1-800-771-7755 or filing a complaint online.

eventually working as a singing waiter at Riccardo's by the Bridge, which closed last year due to the operational impacts of the COVID-19 pandemic.

His career was put on hold while he fought in the final stages of World War II as a combat infantryman. Benedetto returned home in 1946 and brought his talent to Astoria hotspots such as the Shangri-La on Ditmars Boulevard and The Red Door on Steinway Street.

One night in 1949, Pearl Bailey heard him sing and invited him to open for her in Greenwich Village. Bob Hope was in the audience and visited with him after the show.

"Bob Hope came down to check out my act," the singer recalled. "He liked my singing so much he came back to see me in my dressing room

and said, 'Come on kid, you're going to come to the Paramount and sing with me.' First, he told me he didn't care for my stage name and asked me what my real name was. I told him, 'My name is Anthony Dominick Benedetto,' he said, 'We'll call you Tony Bennett.'"

He went on to sell more than 50 million records, with numerous platinum and gold albums to his name. Along the way, Bennett garnered 13 Grammy nominations and the Grammy Lifetime Achievement Award and is one of the select few artists to have new albums at the top of the charts in the '50s, '60s, '70s, '80s and '90s.

"Music and the arts have long been an essential piece of the fabric of New York, and you would be hard-pressed to find someone who has made more of a contribution in this space than Tony Bennett,"

Cuomo said. "Not only is Tony a born-and-bred New Yorker who has been dazzling audiences with beautiful music for more than six decades, but he has always stayed true to his humble New York roots and can always be spotted throughout the city whether he is working on his next painting in Central Park, or just chatting with fans on the street."

Earlier this year, Bennett's family divulged that he was suffering from Alzheimer's disease. His Radio City performances with Lady Gaga, with whom he released a second album entitled "Love for Sale", last week was billed as the last of his illustrious career.

From growing up as a child of immigrants, to all the contributions he has made to our community, Tony Bennett is a New Yorker in the truest sense of the word.

## 'Mr. SALT' & N.J. Ally Fight Ocasio-Cortez to Revive Tax Break

Congressman Tom Suozzi's (D – Long Island, Queens) push to restore the SALT deduction continues to gain steam with the Senate announcing that SALT relief will be included in the outline of the budget plan. A major push by a group of U.S. lawmakers to secure an expansion of the federal deduction for state and local taxes -- which on Monday won inclusion in a critical budget plan -- owes much to a pair of onetime roommates in the nation's capital.

One, Tom Suozzi, has the nickname "Mr. SALT," and the other, Josh Gottheimer, is co-chief of a sometime influential bipartisan House group known as the Problem Solvers.

Together, they've helped to gather a caucus of 33 representatives battling to remove or raise the \$10,000 cap on SALT deductions imposed in the 2017 Republican tax-cut package. Success at getting that included in final legislation this fall would offer relief to middle and higher-income residents in higher-tax states such as New York and New Jersey.

The duo sees the legislative vehicle for the bulk of President Joe Biden's longer-term economic proposals -- a \$3.5 trillion bill made up mostly of social spending measures, funded in part by tax hikes -- as a crucial opportunity to win SALT relief.

The budget blueprint for that package, released by Senate Democrats on Monday, explicitly provided for making the SALT deduction more generous. The White House had left out addressing SALT in its original American Families Plan, leaving it to legislators to address and fund.

### 'Existential Threat'

Suozzi brings the perspective of a former local official to a deduction that's viewed by the SALT caucus as vital to supporting the economies of higher-tax areas that are in turn critical to national output.

"For us, this is an existential threat," explains Gottheimer, who in pre-pandemic days shared living quarters with Suozzi when the two were in the capital. "If the tax base leaves, if well-to-do people leave, that drains the tax base and hurts the programs we all care about."

Suozzi's district includes portions

of Long Island and Queens and Gottheimer's spans the northernmost portions of New Jersey. The two both took office in 2017, months before President Donald Trump signed the tax bill that included a SALT cap to help pay for federal corporate and income-tax cuts.

Suozzi, 58, and Gottheimer, 46, have amassed enough support that Biden's economic agenda can't pass the House without addressing their demands, provided their block of Democrats stays united.

"No SALT, No Deal," is Suozzi's slogan. Gottheimer says, "No SALT, No Dice."

Suozzi, a lawyer and CPA, and Gottheimer, a former speechwriter for Bill Clinton who has worked for Microsoft Corp. and Ford Motor Co., have argued that limiting the SALT deduction hurts residents in their districts and others like them because it raises taxes on middle-income earners who aren't able to claim all their property and income taxes against the federal tax bills.

They argue it prompts wealthier people to move to low-tax places like Florida and Texas, which hurts their state's ability to fund robust social services, an issue that should be a concern to both moderates and progressives.

Liberals counter that the deduction aids higher-income taxpayers, and shouldn't be a priority given greater need to enhance federal support for lower-income families in the social-spending focused bill. It would cost hundreds of billions of dollars to restore the write-off to pre-Trump levels, with more than half of those benefits flowing to households earning at least \$1 million.

Alexandria Ocasio-Cortez, who represents a House district adjacent to Suozzi's, has called his position "a gift to billionaires."

### 'Extreme Position'

"We can have a conversation on the policy, but it's a bit of an extreme position, to be frank," she said.

The rejoinder for SALT relief advocates is that passage can help Democrats in competitive districts.

"This is not a giveaway to the rich -- this is an essential feature to our progressive states," Suozzi said. "The only way we can hold our majority, or expand our majority, is to address this issue."

Suozzi and Gottheimer have been closely linked since they came

to Congress in 2017. Before Covid-19, the pair were roommates when in Washington, living in a shared apartment decorated with a duck-patterned couch that was a cast-off from Gottheimer's cousin. Mike Florio, Suozzi's chief of staff, also lived with them, sleeping on an air mattress in a walk-in closet on the days he was in town.

### County Executor

Suozzi, as county executor for Nassau County, where the median property tax bills consistently rank among the top-five highest in the country, earned praise from constituents for working to institute a cap on that levy. He earned the nickname Mr. SALT for bringing up the issue in nearly every meeting of the Ways and Means Committee, the panel responsible for tax issues.

Gottheimer, who flipped his district from Republican control, arrived at Congress with a raft of corporate-communications experience, and has gone on to co-chair the bipartisan Problem Solvers Caucus -- which gained some success in pushing forward a compromise pandemic-relief plan in late 2020.

"Everything I do is bipartisan. I don't go out to dinner without Republicans," he quipped. Gottheimer also said, "I take much more of the 'let's get 80% of what we want, and get it done' approach."

Democrats will be the ultimate deciders on whether SALT relief passes, as GOP members oppose the broader social-spending bill it would be part of. Senate Majority Leader Chuck Schumer has sponsored a version of Suozzi's SALT restoration bill in his chamber.

### Budget Bill

House Speaker Nancy Pelosi, who also represents a district with some of the highest tax bills in the country, has said she's sympathetic to the issue, though has stopped short of endorsing any SALT plan. The initiative got its biggest momentum boost last month, when Senate Budget Committee Chair Bernie Sanders agreed to include a SALT provision in the draft \$3.5 trillion budget deal.

"In the beginning, this was a long, long shot because the White House didn't include it," Suozzi said. "But, you know, my first campaign slogan was 'Suozzi Gets It Done.' I feel like we are going to get this done."

## QBP Richards, Brooklyn BP Adams Join Health Leaders, Local Officials to Announce New Awareness Campaign in Low-Vaccinated Areas, Encourage Residents in Far Rockaway to Get Vaccinated

Queens Borough President Donovan Richards Jr. and Brooklyn Borough President Eric Adams, along with representation from the Bronx Borough President's Office and the New York City Department of Health and Mental Hygiene (DOHMH), held a joint press conference with public health leaders, local elected officials, and community advocates outside the City's Beach 39th Street Vaccine Hub to urge Far Rockaway residents to get vaccinated. At the press conference, Borough President Adams, Queens Borough President Richards, and other local leaders touted the fact that they have been vaccinated, and reassured residents, particularly in traditionally underserved communities, that the vaccines are safe, effective, and save lives.

"New Yorkers have been resilient in the face of the COVID-19 pandemic, especially here in Queens. However the pandemic is far from over given the rise of the Delta variant. It is more important than ever to ensure everyone gets vaccinated so they can protect themselves, their loved ones and their neighbors," said Queens Borough President DONOVAN RICHARDS. "The vaccines are safe, effective, and free, and I am proud to stand with Brooklyn Borough President Eric Adams, Bronx Deputy Borough President Marricka Scott-McFadden and the DOHMH to launch this partnership and urge our much-needed communities to get their doses."

"This virus, and the new Delta variant, are formidable opponents. But we have a strong weapon on our side: vaccines. We have seen that this pandemic does not respect national, state, city, or borough borders. That's why we have to encourage as many New Yorkers as possible to get vaccinated as soon as possible," said Brooklyn Borough President ERIC ADAMS. "To get vaccination rates up across the five boroughs, we need a combination of smart policies and aggressive outreach through credible messengers. I'm proud to join Queens Borough President Richards, DOHMH, and other local leaders to urge residents in Far Rockaway to get vaccinated."

The Borough Presidents announced a new City partnership that will incentivize local businesses to refer patrons and community members for vaccination through \$100 payments to participating businesses, adding to the existing \$100 incentive available to individuals who have not yet been vaccinated. The program will advance the twin goals of boosting vaccination rates while supporting struggling small businesses in economically underserved areas.

The partnership builds on the 'NYC Vaccine Referral Bonus' program, launched by the City in June of this year, which engages small businesses, community-based organizations, parent-teacher associations (PTAs), houses of worship, and other local institutions to turn out their neighbors,

awarding \$100 for each referral that leads to an individual's receiving their first dose of the COVID-19 vaccine at a City-run site. Each organization is eligible for up to \$20,000 in incentives, representing 200 referrals in total.

In the coming weeks, the Borough Presidents will announce future events in other areas around the city that suffer from low vaccination rates to ensure vaccinations continue to rise and New York beats back the surge in cases. Next steps include canvassing events in small business corridors in Brooklyn and Queens to inform local business owners of the \$100 incentive and the influential role they can play as community anchors in advocating for their customers to get vaccinated.

"Our road to recovery starts with everyone getting vaccinated. I urge everyone to get the COVID-19 vaccine — they are safe, free and effective at protecting you against the worst outcomes of this virus," said NYC Health Department First Deputy Commissioner Dr. Torian Easterling. "Thank you to all of our partners in government and in the community for working together to make our city safe from COVID-19."

"In The Bronx, we were hit particularly hard by the COVID-19 pandemic, and increasing vaccination rates will play a key role in our city's recovery," said Bronx Borough President RUBEN DIAZ JR. "It is critical for the health of ourselves, our families and our fellow New Yorkers that we get the vaccine and beat the virus together. I want to thank my colleagues Borough President Donovan Richards, Brooklyn Borough President Eric Adams and The New York City Department of Health and Mental Hygiene for their partnership in getting the message out that the vaccines are safe, effective and accessible in all corners of our City."

State Senator James Sanders Jr. is partnering with Neighborhood Housing of Jamaica to host a weekly, virtual, one-on-one clinic to help small landlords and tenants as the post-COVID eviction moratorium is about to come to an end. He made the official announcement today outside the Queens Civil Court House in Jamaica.

Senator Sanders was joined by many small landlords who are experiencing distress and shared their first-hand experiences and why this program is needed.

Always a leader, this is the first program of its kind in the country. The moratorium in New York is set to expire on August 31, 2021 and the federal moratorium will expire on October 3, 2021, but there is no denying the inevitable.

"There are going to be a whole lot of people facing a world of pain," Sanders said. "It is our job as leaders in government to take the steps necessary to help our constituents and be stewards of good will."

Congresswomen Cori Bush, Ayanna Pressley and Ilhan Omar slept outside the U.S. Capitol to protest the expiration of the moratorium of federal evictions.

"This is something that is



so serious and affects so many people," Sanders said. "We are talking about thousands of people potentially becoming homeless."

The courts will be overloaded with landlords who cannot pay their mortgages due to non-paying tenants and tenants who cannot pay their rent due to job loss and other COVID-related circum-

stances. In both cases, each side is going to desperately need help and Senator Sanders along with NHSJ is going to provide that assistance.

## Pheffer Amato, Addabbo, Anderson, And Advocates Urge Governor's Office to Sign Bill Forming Water Safety Commission

Assemblywoman Stacey Pheffer Amato (D-South Queens) hosted a press conference in support of her bill with Senator Tim Kennedy, A.7734/S.7129. This bill would create a commission to investigate best practices in preventing childhood drowning. Members of the Water Safety Coalition, local elected officials, and community leaders were in attendance.

"No matter where you live or what your background is, you should feel safe going into the water or know when not to go into the water," Pheffer Amato said. "This bill is for the children who lost their lives, their families, and every other person in New York State who we must protect. This bill can lay the groundwork for protecting a whole generation of children from preventable fatality due to lack of knowledge on water safety, and it gives me hope for a safer future. We are here today to urge Governor Cuomo to sign this bill into law. There is too much at stake, and too much to lose."

"We are lucky enough to have some amazing swim education programs here on the Rockaway Peninsula, but it is beyond time that we as a state take on the responsibility of expanding access to these vital programs into communities all across New York," State Senator Joseph P. Addabbo, Jr. said. "Proper swim education can mean the difference between life and death in the water, and this legislation will allow people of all ages — but especially children — the opportunity to learn how to swim and will save lives. We



respectfully ask the Governor to sign this bill into law."

"Water safety programs save lives," Assemblymember Khaleel Anderson stated. "Each year, we grieve heartbreaking but often preventable drowning tragedies that statistically surge in the summer months. Particularly in beachside communities like Far Rockaway and throughout New York State, we must invest in high-quality water safety programs to prevent these avoidable drownings. The creation of a Water Safety Commission is also a matter of racial justice as Black and brown communities suffer disproportionately from a lack of access to water safety and swimming education. I stand alongside Assemblymember Stacey Pheffer Amato and the Water Safety Coalition as they call on the Executive to sign this bill into law."

"All members of our community should be able to safely take advantage of Rockaway's largest

public facility - the beach!" Clare Hilger, member of the Water Safety Coalition and secretary of the Rockaway Beach Civic Association, said. "Improving our community means educating our community about water safety. We need to focus on communities that have previously been ignored and empower children with the knowledge to save lives."

"The answer to keeping our children safe from drowning and water-based accidents is not to keep our children away from water," Shawn Slevin, founder of Swim Strong Foundation, said. "It is to educate them about the nature, challenges and behaviors of different bodies of water so they can make decisions that will keep them safe in, on and around water. It is also to teach them swimming skills to navigate water with competence and confidence so they can enjoy all of the ben-

## Pheffer Amato and Addabbo Secure Passage of Whippets Bill in Assembly and Senate



Assemblywoman Stacey Pheffer Amato (D-South Queens) announced that her bill, A.754A/S.2819A, has passed both the State Assembly and the State Senate, and is awaiting the Governor's signature. The bill will make it illegal for children under age 21 to purchase whipped cream canisters ("whippets"), which can be used as drugs. This bill was sponsored by Senator Joseph Addabbo in the Senate.

"I am very happy that my Assembly and Senate colleagues have passed this bill. It is clear that we need to get whippets out of the hands of teenagers in our communities," Pheffer Amato said. "In my community, empty whippets are all over our streets, and this will go a long way toward keeping our kids safe and our streets free of debris. This bill will greatly improve quality

of life in my district, and I look forward to the Governor signing it into law."

"My office has received countless complaints about discarded whippets canisters littering the streets, and we even conducted a cleanup of the Addabbo Bridge where we found several dozen of these canisters strewn about," Addabbo said. "Bill S.2819A/A.754A hopes to keep these canisters out of the hands of children under the age of 21 who may be using them to get high on the nitrous oxide, while allowing for businesses with legitimate uses for them to still be able to purchase them. My thanks go to Assemblywoman Pheffer Amato for sponsoring this piece of legislation and helping it pass in the Assembly." This bill now awaits the signature of the Governor before it will become law.

## Maloney, Nadler, Garbarino, & Gillibrand Introduce The Bipartisan 9/11 Responder And Survivor Health Funding Correction Act

The lead sponsors of the bipartisan James Zadroga 9/11 Health and Compensation Act, which created the World Trade Center Health Program (WTCHP) and reopened the September 11th Victim Compensation Fund (VCF), announced the introduction of the 9/11 Responder and Survivor Health Funding Correction Act. This legislation - introduced by Reps. Carolyn B. Maloney, Jerrold Nadler, and Andrew Garbarino in the House and U.S. Senator Kirsten Gillibrand in the Senate - would address a funding shortfall in the WTCHP and ensure its adequate funding now and in the future. It would also make minor corrections to the 2010 statute and authorize the program to develop a research cohort to study the impact of the toxic exposures and psychological trauma on the more than 35,000 people who were children at the time of the attack and resided or attended school or daycare in the NYC disaster area in the aftermath of the attack.

The WTCHP provides medical treatment and monitoring for over 100,000 responders and survivors from the World Trade Center and lower Manhattan, the Pentagon, and the Shanksville, PA crash site, who live in every state and in 434 out of 435 Congressional Districts. While Congress extended the program to 2090, the funding needs of the WTCHP exceed the current funding formula. Because of that, in the coming years, the WTCHP will not have sufficient funds to provide care for all those still suffering the physical and mental impacts of 9/11. This includes responders and survivors who will be newly diagnosed with 9/11-associated cancers caused by their toxic exposures.

"Our country made a promise after 9/11 to always be there for the firefighters, the police, the EMTs, the workers clearing the pile, and survivors, residents, area workers, and students who got sick or injured from the toxins at ground zero," said Congresswoman Carolyn Maloney. "A promise we kept when we made the 9/11 health program essentially permanent. The funding provided in the 9/11 Responder and Survivor Health Funding Correction Act will ensure that everyone impacted by this tragic event gets the care they rightfully

need and deserve."

"As the twenty-year anniversary of the September 11th approaches, we must all reflect on the cost borne by the heroic responders and survivors made ill by their exposure to toxins in the days, weeks, and months after the attack. Just as they did not fail us in the aftermath of that terrible day, we cannot fail to provide them with the support that they deserve," said Congressman Jerrold Nadler. "I'm proud to introduce the 9/11 Responder and Survivor Health Funding Correction Act, which will ensure that the World Trade Center Health Program remains fully funded and survivors and responders receive the care they need. It's the right thing to do."

"The World Trade Center Health Program provides medical services to first responders and survivors impacted by the 9/11 terrorist attack, but the program is quickly running out of funds," said Congressman Andrew Garbarino. "It's essential that we ensure the program has the resources it needs to continue to help those still suffering the long-term effects of this horrific attack. I'm proud to help introduce this bipartisan legislation to replenish funding for this program so that those who need it most continue to have access to care."

"The victims of September 11th are not just the men and women killed on that terrible day – countless American lives continue to be claimed by illnesses linked to the attacks," said Senator Gillibrand. "In 2011, we established the World Trade Center Health Program (WTCHP) to provide first responders, survivors and their families with the health care benefits needed to treat 9/11-related health conditions. Today, we must uphold that promise and ensure that the program will have the funds it needs now and into the future. I'm urging my colleagues to prioritize and pass the 9/11 Responder and Survivor Health Funding Correction Act, and to remember that "we will never forget 9/11" is not just a slogan, but a reality we must uphold."

As the nation observes the 20th Anniversary of the 9/11 attacks, this legislation is needed to ensure that the slogan that we will "Never Forget 9/11" is a reality and that 9/11 responders and survivors

will continue to get the care that they need and deserve.

Background - After the attack on September 11, 2001, thousands of responders rushed to the scenes and spent months combing through the wreckage looking for remains. In New York, the residents and workers were urged by the government to return to their homes and business and reopen the Financial District. The federal government assured them that the air they were breathing was safe, when in fact it was filled with toxic pollutants that continue to kill and disable 9/11 responders and survivors to this day.

In 2010, Congress finally responded to this health crisis with bipartisan action by passing the James Zadroga 9/11 Health and Compensation Act, which created the WTCHP and reopened the September 11th Victim Compensation Fund. In subsequent years, Congress, with bipartisan support in 2015 and 2019, moved to expand both programs' funding and extend their authorizations to ensure that both those injured and their families would get the help they need and deserve.

the Rockaways," said St. John's Episcopal Hospital Vice President of External Affairs RENEE HASTICK-MOTES. "In addition to providing the vaccine at our ambulatory locations, residents may also walk-in to our Patient Express Center (PEC) located on our hospital campus Tuesdays and Thursdays between 5PM and 8PM to receive the vaccine. No appointment necessary."

"The COVID-19 pandemic has not only impacted our physical well-being but also our mental health. Based on research my team and I conducted, Queens children and adults are experiencing high anxiety and depression," said Child HELP Partnership Founder and Executive Director DR. ELISSA BROWN. "These symptoms are correlated with exposure to trauma and stress, but not specific to COVID-19. As a result, they may not be

focused on the pandemic and vaccination. It is now more critical than ever we spread the word about vaccines so we can move forward from this pandemic once and for all."

The Delta variant of COVID-19 continues to cause a troubling rise in positive coronavirus cases citywide. As of August 5th, the city-wide positivity rate stands at 3.27 percent. Areas with low vaccination rates are particularly vulnerable to the Delta variant, according to public health experts.

In April, Queens was the first county in the state to have 1 million residents vaccinated. In two dozen ZIP codes across Queens, more than 70 percent of eligible residents have received at least one dose of a COVID-19 vaccine as of Thursday, August 5th. In total, 67 percent of Queens residents — just over than 1.5 million people — have received at least one vaccine dose, by far the second-highest total

of the five boroughs and six percentage points higher than the City average.

However, vaccination rates in historically underserved communities across Southeast Queens and the Rockaway Peninsula have lagged other areas. As of Thursday, ZIP Code 11691, made up of Far Rockaway and Edgemere, has the lowest vaccination rate of any ZIP code in the City of New York with just 38.85 percent of eligible residents having received at least one vaccine dose.

The COVID-19 pandemic disproportionately impacted Far Rockaway. According to City data, the virus has been either the confirmed or probable cause of death of 535 Far Rockaway and Edgemere residents as of Thursday, the second-most of any ZIP code in the borough, while a total of 8,605 residents living in ZIP code 11691 have tested positive for COVID-19 over the course of the pandemic.

efits being in water brings to our lives. Swim Strong is happy to support Senate Bill 7129/Assembly Bill 7734, which will create a commission to prevent childhood drowning by evaluating and developing programs to educate children on water safety and teach them swimming skills."

"Our civic association has been working on this issue for a long time." Ed Williams, president of the Heart of Rockaway Civic Association, said. "Assemblywoman Pheffer Amato was one of the first people to elevate the conversation happening in this community. We join her in urging

the Governor's office to see the value of this bill, because it is truly a matter of life and death."

"Making it mandatory in New York State schools would work toward fixing the disparity in underserved populations because swim lessons and water safety knowledge have been largely something that only affluent families can afford for their children," Kaitlyn Krause, founder of Rising Tide Effect, said. "This knowledge should not be a matter of money, especially when we have the resources already available. All human beings should have the right to access this life-saving skill."

"Working with the Laru Beya Collective has al-

lowed us to reach some but this bill will guarantee the reach of many," Cynthia Hicks, leader of the Laru Beya Collective, stated. "Passing the water safety initiative will begin to allow the availability to ensure the survival of our up and coming young swimmers who without this bill would be missing out on an essential skill for life."

welcoming entryway into the park.

Bordered by 82nd Street and Broadway, this property was once home to Reverend John Moore (1620-1657), the town's first minister. In 1954, it was converted to Elmhurst Playground. The City Council

renamed the playground to commemorate the location of the Moore homestead in 1987. The property is also known as the birthplace of the famous "Newtown Pippin" apple which arose from the farm of Gershom Moore, Captain Samuel Moore's brother. In December 2013, the City of New York adopted the Newtown Pippin as its official apple.

## New York State Announces \$200 Million in Additional Food Assistance for August

**All SNAP Recipients In New York Will Receive Maximum Food Benefits Emergency Allotment has Brought More than \$2.7 Billion in Food Assistance**

The state Office of Temporary and Disability Assistance today announced that all New Yorkers enrolled in the Supplemental Nutrition Assistance Program will receive the maximum allowable level of food benefits for August. The agency is also working with the federal government to ensure these supplemental benefits continue to reach households in need through September and beyond.

"The struggles many New Yorkers experience daily were laid bare and exacerbated by the global health crisis," Commissioner Mike Hein said. "These additional

food benefits offer critical support for the many individuals and families that grapple with food insecurity throughout our state."

SNAP households already receiving the maximum monthly benefit, and those that had been receiving an emergency allotment of less than \$95 per month, will receive a minimum supplement of \$95. Nearly 1.6 million households in New York State will receive the supplemental benefits later this month, which will result in the state receiving roughly \$200 million in federal assistance.

SNAP households in all counties outside of New York City should see these benefits post starting Aug. 10. Those SNAP households in the five-county New York City region should see their benefits post between Aug. 16 and the end of the month.

While New York's emer-

gency declaration expired in June, OTDA obtained approval from the federal government to extend the emergency allotments based on the continued public need due to COVID-19. As a result, New Yorkers will continue to receive the maximum SNAP benefit for as long as the federal emergency declaration continues in 2021.

As during prior months, the payments will be delivered directly to recipients' existing Electronic Benefit Transfer account and can be accessed with their existing EBT card. Like regular SNAP benefits, the supplemental benefits can be used to purchase food at authorized retail food stores. Any unused SNAP benefits will be automatically carried over to the following month.


