#### **Con Edison Warns Customers Not To Fall For Scam Callers**

Refer Suspicious Calls to Police or 1-800-75CONED

Con Edison is warning customers not to fall for scams in which a caller threatens a service turnoff unless the customer purchases a pre-paid card or arranges for a transfer via MoneyGram to pay a bill.

These callers are not from Con Edison and Con Edison does not accept payments of electric or gas bills by pre-paid debit cards, or by MoneyGram or similar transfers.

The company has recently seen a spike in reports from customers who were contacted by the scammers. Con Edison believes the scammers are calling customers randomly, not targeting just those who owe back payments. The company has received complaints from residential and business customers.

The scammers sometimes even tell the customer about a store near the customer's home that sells pre-paid cards. The scammer instructs the customer to pay cash to put money on the card and to then provide the number on the card to the person who called.

Once the customer provides the scammer with the card number, the scammer steals the money on the card.

There have even been reports of these scammers making a Con Edison phone number show up on the customer's caller ID.

With MoneyGram, scammers may ask a customer to provide money from a bank account, credit card or debit card by going online or to a specified location. The money goes into someone else's bank account or is available for the receiver to pick up in cash.

Be alert if anyone asks you by telephone to arrange for prepaid debit cards or a MoneyGram transfer as payment for your bill, or to send money to an out-of-state address. Never arrange payment or divulge account or personal information, including debit or credit card information, over the telephone, unless you are certain you are speaking to a Con Edison representative.

Anyone who feels they may have been a target of an imposter or a payment scam should call their local police department. They may also call Con Edison at 1-800-75CONED.

## Cong. Meng And Tonko Elected **Regional Whips For New York**

## **Read Magazines for Free on Your Phone With Queens Library Card**

You can now read hundreds of magazines for free on your phone and all you need is a Queens Library card.

Library patrons can now use their phones and tablets to access a new web portal with free digital copies of popular magazines like National Geographic, The New Yorker, Elle, Forbes, Rolling Stone and Vogue, the library said.

The portal, digitalq.nyc, known as Digital Q, lets users read magazines without downloading an app, the library said. Instead, the site serves as a direct line into the library's digital magazine collection of more than 10,000 issues.

The idea is the brainchild of Queens Library President and CEO Dennis Walcott, who, before taking over the library earlier this year, volunteered at Queens Hospital Center.

At a recent event at the hospital, where the portal was launched, Walcott said that the notion came to him when, while watching both patients and their relatives, he realized that "sometimes they're

having idle time and not having something accessible to do."

"What we want to do is give them that opportunity to participate in having something to do ... and

something to read," he added. In the future, the portal will also include other parts of the library's digital collection, such as e-books and e-music, according to Queens Library spokeswoman Elisabeth de Bourbon.

In an effort to provide more readers with better access to digital reading materials, anyone interested in using the portal can now sign up for an e-card providing only name, phone number and date of birth, the library said.

"It takes only seconds to receive an e-card and pin after that information is submitted," de Bourbon said in an email. "Users can't start streaming unless they have an e-card."

Until now, library users had the option to download magazine issues onto their desktops, but could not access them on their phones, the library said.

### **House Passes Meng Legislation to Strengthen Rewards Program That Fights Terrorism and International Crime**

U.S. Rep. Grace Meng (D-NY) announced today that the House has passed her legislation to strengthen the Rewards for Justice Program, a key government initiative used to fight terrorism and other international crimes.

The program allows the Secretary of State to pay cash rewards for information that leads to the apprehension anybody involved in international terrorism, narcotics trafficking, transnational crime, war crimes, crimes against humanity, or genocide.

Meng's measure would add rewards for those who provide information on individuals who "aid" or "abet" war crimes, crimes against humanity, or genocide. Currently, people who offer information on individuals who "aid" or "abet" these kinds of criminal acts do not qualify for this type of financial reward.

"The Rewards For Justice Program is a great tool in our country's fight against terrorism and other crimes, and my provision would make it even better," said Meng, a member of the House Foreign Affairs Committee. "It is critical that we use all resources at our disposal to bring international criminals to justice. I look forward to this legislation now moving through

## CHIN CHIH YANG IS AT IT AGAIN by Merle Exit

An art project made up of one thousand recycled aluminum cans is on display at COPE NY located in the former Pfizer Building at 630 Flushing Avenue in Brooklyn, very typical of visual artist Chin Chih Yang. It may not be obvious that a 32 foot long LED lighted "arrow" is pointing at an abstract human head, part of an installation of artists through December 16, 2016.

ChinChih, who hails from Taiwan, is quite known for using both crushed and thin strips of aluminum cans to create his art style. One piecethat had been shown as part of an event through the Taiwanese American Arts Council, "Pollution Solution" was made up of strips of aluminum cans to create a net and backed by LED lights. He wrote, "Unfortunately, pollution has become an integral part of our lives. We ourselves are the only ones who may be able to come up with a collective solution to this dilemma". In 2012 ChinChihpresented his interactive performance art piece, "Kill Me or Change", in front of the Queens Museum. 30,000 aluminum cans were dropped on the artist in an effort to call attention to the effects of overconsumption in modern society.

Aside from the ability to reflect light, Chin Chih sees these aluminum cans as something close to our bodies as an "everyday use". "It's very strong, shiny and beautiful material," said



Chin Chih. "But, they are also poisonous to both our bodies and the air around us when recycled."

On opening night, November 19th, Chin Chih donned an "aluminum cape" as part of his interactive performance. Cans are collected from all over New York City as well as having it known that he does so as people collect for him. Where does he store the tremendous amount of cans? He has a house outside of New York City.

## When Might Opening a Joint Bank **Account Make Sense?**

Did you recently get married, move in with a new roommate, see a child off to college or start managing a relative's finances? The change in relationship dynamics could prompt you to consider tying part of your financial lives together by opening a joint bank account.

You might enjoy the conveniences a joint account offers, or you could see it as a symbolic step in your relationship. But before you open a bank account with someone else, consider the potential benefits and drawbacks of the arrangement.

First, here's a quick introduction to joint accounts. Individual and joint accounts are similar in many ways. You can open a joint account at an online-only bank or local bank branch. However, with a joint account both co-owners can deposit or withdraw money as if it was an individual account. The account holders can also write checks, make online payments or transfers and use the account's debit cards (if it offers them) to make purchases or withdrawals.

Let's start with a few situations where you might want to use a joint bank account, followed by examples of why the arrangement might not make sense for You might want a joint account if you share financial responsibilities with someone else. Sharing a joint account could be a good option if you're married or living with a significant other. Some couples keep their individual accounts and also create a joint account where they deposit a portion of their paychecks and use the money to pay for household expenses or a shared savings goal.

With two people contribution to and watching a shared account, it could be easier to meet minimum balance requirements and identify savings opportunities. Some accounts also offer higher interest rates the more money you have in the account.

A shared account could also help you care for a family member. A joint bank account could help you care for relatives, whether they live nearby or in another state. With co-owner access, it'll be easy to deposit or transfer funds online and at a bank branch, pay the person's bills from the account and keep an eye on the account's activity and balance.

But beware, joint accounts give everyone full ownership of the money. No matter who makes the deposit, once money is in a joint account, each member "owns" it and can legally spend it however he or she wants. In other words,

you might not have any recourse if your new roommate raids a joint account and spends the rent money on a weekend getaway.

A joint account holder's debt could also spell trouble for everyone on the account. Because every joint account holder has equal rights to the money, creditors can go after the money in a joint account if they sue one of the account holders. Meaning all the money is risk if one person gets sued, falls behind on bills or doesn't pay taxes.

If you're considering using a joint account to help manage an older relative's finances, a convenience account or getting power of attorney may be potentially safer alternatives.

Communication and trust are vital to managing a joint account. Lack of communication between joint account holders could lead to overdrawn accounts or low balances, and the corresponding fees. It can also lead to disputes if the owners have different ideas of how the money should be spent.

Some co-owners make an informal agreement before opening an account together. Although it won't have legal backing, you could create a rule that you have



#### Mayor De Blasio and NYCHA Announce Completion of Roof Replacements at Queensbridge Houses, North America's Largest Public Housing Development

\$87 million at Queensbridge part of \$300 million capital investment throughout NYCHA placing new roofs on 263 buildings

Mayor Bill de Blasio and New York City Housing Authority (NYCHA) Chair Shola Olatoye today announced that NYCHA completed comprehensive roof replacement work at Queensbridge Houses – months ahead of schedule – bringing major capital upgrades and improved quality of life to more than 6,500 residents.

'Leaks in old roofs are the root cause of mold and other major problems our NYCHA residents face. So we did something no administration has ever done: put \$300 million of City money towards major repairs for our residents," said Mayor Bill de Blasio. "Today, we continue to turn a corner and fulfill our commitment to make critical investments that help protect our residents and ensure public housing continues to improve. A focus on infrastructure, investment and increased access guide our ambitious vision for clean and connected public

NYCHA replaced aging roofs, repaired exterior brickwork, and replaced window sills on all 26 residential buildings at Queensbridge Houses, the largest public housing development in North America with over 3,000 units. The work, which represents an \$87 million investment, including \$60 million in funding from Mayor de Blasio and \$27 million in federal funding, ensures the buildings are weather-resistant, decreasing occurrence of leaks and further protecting the buildings' infrastructure.

Originally to be projected complete in July 2017, NYCHA completed this work months ahead of schedule thanks to a proactive and collaborative relationship between the contractor, NYCHA's construction management team and the Queensbridge Houses development staff.

NYCHA Chair and CEO Shola Olatoye said, "As we work to preserve public housing for this generation and the next, we're strengthening our buildings with top-to-bottom upgrades – literally. Thanks to Mayor de Blasio's unprecedented investment in comprehensive roof replacement and façade repairs across NYCHA, Queensbridge residents will see a healthier, cleaner community, with fewer leaks and improved quality of life."

Leaky roofs are the main cause of water and moisture entering a building, and the accumulated moisture contributes to mold, leaks and physical damage to the buildings' interior. NYCHA anticipates the new roofs and window sills and repaired brickwork will:

- Preserve physical structures by safeguarding them from incoming moisture, saving money on repairing moisture damage
- Eliminate core symptoms of mold in NYCHA buildings, protecting residents and improving their quality of life
- Reduce operating expenses by making buildings more efficient



The work at Queensbridge is one part of Mayor de Blasio's \$300-million investment in roof replacement and façade repairs at NYCHA developments citywide, which will place new roofs on more than 250 NYCHA buildings. NYCHA is supplementing that investment with an additional \$80 million in federal public housing capital funds.

Additional investments improving quality of life at Queensbridge Houses:

The Mayor's major investment in comprehensive roof replacements is just one of a series of large-scale investments being made in the Queensbridge Houses community to improve residents' quality of life for this generation and the next.

In July 2015, in partnership with the U.S. Department of Housing and Urban Development (HUD), the de Blasio Administration announced a \$10 million investment in free high-speed broadband service in five public housing developments citywide, including Queensbridge North and South. Additionally, Queensbridge is one of 15 NYCHA developments targeted by the Mayor's Action Plan for Neighborhood Safety, a comprehensive initiative to reduce crime and strengthen neighborhoods in the 15 New York City Housing Authority developments that accounted for 20 percent of all violent crime in the City's public housing in 2014. City investments in the Queensbridge Houses community include:

- \$10 million to provide free broadband at 5 NYCHA developments, including Queensbridge – installation underway
- \$13.6 million for installation of permanent, state-of-the-art safety lighting as part of the Mayor's Action Plan for Neighborhood Safety – installation underway
- \$14.7 million for installation of CCTV and higher-security Layered Access Control (LAC) Doors, which are operated by computer system and fob keys
- \$1.65 million for grounds improvements, including upgrades to recreational spaces
- \$850,000 for upgrades to the Community Center
- \$2.1 million to reactivate storefronts with additional workforce development programming

The Mayor's Action Plan for

Neighborhood safety also funds a series of initiatives aimed at increasing pathways to opportunity and creating more connected public housing communities, including mentoring and jobs programs for young adults and Community Center programming for seniors.

Congresswoman Carolyn Maloney said, "I was proud to help bring \$27 million in Federal funding to Queensbridge Houses to aid in the necessary replacement of roofs on all 26 residential buildings. This project will have an immediate impact on the quality of life for over 6,500 residents. By replacing the roofs, the de Blasio Administration has ensured that there will be fewer leaks throughout Queensbridge, which will help to prevent mold and physical damage to the residences. It is wonderful that they were able to complete the work six months ahead of schedule, which will make for a much more comfortable winter. Investing in Queensbridge is incredibly important. We must all work together to ensure that these buildings continue to stand and provide homes for generations to

State Senator Michael Gianaris said, "Queensbridge residents have waited too long for simple repairs that will create a healthier and safer environment. These new repairs will improve living conditions and better the quality of life for thousands of our neighbors. I look forward to continuing my work to preserve public housing for present and future generations."

Assembly Member Catherine Nolan said, "I am thrilled that NYCHA has completed this essential project ahead of schedule. Repairing and improving these roofs was long overdue. Residents of Queensbridge Houses deserve to live in a safe, healthy environment. I would like to thank Mayor de Blasio for visiting Queensbridge and making this much-needed investment. Congratulations."

Council Member Jimmy Van Bramer said, "I'm thrilled that this \$87 million city investment in our community has been completed. Queensbridge residents deserve to live in high-quality, modern buildings. These new roofs and facades will prevent leaks and mold and strengthen and preserve the nation's largest public housing development for years to come."

## House Passes Meng Legislation to Create Zip Code For Glendale, Queens



Legislation sponsored by U.S. Rep. Grace Meng (D-Queens) that would provide Glendale, Queens with its own ZIP code was passed late this afternoon by the House of Representatives.

"For almost thirty years, the residents of Glendale have sought to obtain a ZIP code for their community and the passage of this legislation is a giant step in finally making that happen," said Meng. "Residents of Glendale have experienced mail and service related problems due to sharing the 11385 ZIP code with the neighboring community of Ridgewood. These problems include medications that were spoiled or not received due to mail processing errors, delays in first responder services to residents in need of care, and inaccuracies with GPS devices. Glendale also deserves to be recognized as its own community. I applaud this vote and I thank my colleagues for supporting it."

"I am delighted that the Glendale ZIP code issue is finally

coming to the attention of the House and the Postal Service," said former Rep. Bob Turner (R-Queens) who was the last member of Congress to work on the issue before Meng. "Hopefully, this can get done in a quick and bipartisan manner."

Meng's measure passed as part of a broad bipartisan postal bill (H.R. 6303) that establishes ZIP codes and renames post offices throughout the U.S. Her legislation was included in the bill after she urged the Chair and Ranking Member of the House Oversight and Government Reform Committee to attach it to any postalrelated legislation that the panel may pass by the end of 2016 (when the current session of Congress ends). The Committee on Oversight and Government Reform is the panel with jurisdiction over postal issues.

Meng's legislation would require the United States Postal Service to designate a single, unique ZIP code for the area that encompasses Glendale, New York. The Congresswoman introduced the bill in February 2015. She also sponsored a version in 2014 during the last session of Congress.

H.R. 6303, which passed by voice vote at approximately 4 p.m., must still be approved by the Senate and signed into law by the President. Under the bill, the Postal Service must create a ZIP code for Glendale by September 30, 2017

#### Schumer Announces Bi-Partisan 'Bots Act' Passed Senate

Senator Urges House To Act; Law Finally Cracks Down On Cyber Scalpers Who Scoop Up Thousands Of Popular Broadway & Concert Tickets & Then Sell Them At Outrageous Prices

U.S. Senator Charles E. Schumer announced Senate passage of the "BOTS Act," federal legislation that would crackdown on cyber scalpers using bots to scoop up thousands of popular Broadway, theater and concert tickets to resell on other websites at outrageous prices. Earlier this year, Schumer teamed up with award-winning composer, lyricist, performer and Hamilton creator, Lin-Manuel Miranda, to highlight the need for this legislation. Schumer said that, most recently, cyber scalpers have been using online computer programs, known as "bots," to purchase Hamilton tickets and reselling them anywhere between \$500 to upwards of \$2,000/ticket, up from approximately \$189/ticket. Schumer's legislation would help fix the broken system of ticket purchasing. Now that the bill has passed the Senate, Schumer is calling on the House of Representatives to act before the end of this year.

"No ifs ands or bots about it, now that the 'BOTS Act' has passed the Senate, it's up to the House to sweep the stage of bots so that actual fans can enjoy Hamilton, other hit Broadway shows and major concerts," said U.S. Senator Charles Schumer. "These bots have gotten completely out of control and their dominance in the market is denying countless fans access to shows and concerts and driving prices through the roof. This legislation will finally crack down on online hackers and scalpers that use 'bots' to purchase thousands of tickets in a matter of milli-seconds, and then sell them at outrageously-inflated prices."

Schumer continued, "By eliminating 'bots' and slapping hackers with a hefty fine, we can better ensure those who want to attend shows in the future will not have to pay outrageous, unfair prices. I hope that the House will pass this legislation before the end of the year so that Broadway and concertgoers in New York and across the country have equal access to these tickets."

"The Broadway League applauds Senator Schumer's leadership and for making the 'BOTS Act' happen in such a timely manner. Theatergoers from around the world are being defrauded by excessive mark-ups on tickets to their favorite shows, and we are pleased this legislation will give law enforcement and the Broadway community the ability to take steps to prevent this situation from affecting our patrons. Broadway is an iconic industry that entertains millions, supports our nation's cultural heritage and generates billions of dollars for America's economy. We are incredibly grateful to Senator Schumer for his continuous support," said Charlotte St. Martin, President of the Broadway

According to the New York Times, between 2012 and 2014, just three scalpers bought more than 140,000 tickets to New York shows using bots. Scalpers using bots have purchased more than 20,000 tickets to Hamilton. According to the New York Times, scalpers earned more than \$15.5 million from the 100 Hamilton performances before Lin-Manuel Miranda's final performance. Schumer said cyber scalpers are making millions of dollars each year using bots to rip off fans, while also keeping millions of dollars in ticket revenue away from artists and performers and all those work on these live productions.

Schumer explained that "bots" are sophisticated computer programs often used by nefarious scalpers and brokers that plague the online sale of concert tickets. According to a 2013 New York Times report, while bots were once merely a nuisance to the live music industry, they have now become arguably its most reviled foe, as they are able to snatch up popular tickets within a matter of seconds, leaving fans with no choice but to buy tickets through derivative sites at much higher prices. Schumer said this practice leaves frustrated fans ticket-less and drives a resultant secondary ticket sale market, where tickets are sold at astronomical prices that most fans cannot afford.

In New York alone, hundreds of thousands of tickets are purchased any given day by scalpers using bots. For instance, at a U2 concert at Madison Square Garden, one scalper used a bot to buy more than one thousands tickets in the first minute after tickets went on sale, even though there was a four-ticket per fan limit. Between 2012 and 2014, just three scalpers bought more than 140,000 tickets to New York shows using bots. According to Ticketmaster, an estimated 60 percent of the most desirable tickets available for sale are purchased by bots.

Schumer said there is no fair way for a consumer to purchase a ticket online if they have to compete with bots that are capable of navigating through online ticket websites and purchasing tickets in the matter of seconds, jamming up the online ticketing system, and thereby leaving an unfair playing field for fans looking to purchase seats to an event or concert at the face value price.

Schumer's legislation would prohibit the unfair and deceptive act of using mechanisms such as bots in order to scoop up tickets before consumers are given a fair chance to buy them. Schumer said this legislation would help ensure consumers are given equitable access to tickets for events in the future and are not precluded from purchasing tickets at a fair price. Now that the bill has passed the Senate, Schumer is pushing the House of Representatives to pass the Better On-line Ticket Sales Act of 2016, or the BOTS Act, in order to increase fairness for consumers in the ticket-purchasing industry.

Artists, musicians, theater owners and concert promoters alike have led the charge against the bots used by online hackers and scalpers in an attempt to improve the ticket-buying experience for customers and guarantee increased transparency for fans.

There is a need to shift our business culture."

Other ideas that came out of today's panel include: developing policies and protocols for small business owners who want to be inclusive and support the larger community; creating a manual and training program on how managers and workers can treat customers with dignity and respect; and, creating more resources for businesses interested in hiring English-speaking workers and displaying English language marketing materials.

"The Chamber has already developed a member decal to identify which businesses in our community have the highest standards," stated John Choe, Executive Director of the Greater Flushing Chamber of Commerce. "We will be using these decals and other marketing tools to heavily promote the best in our business community - and asking local residents and customers to support these businesses as well."


